Enclosed is a copy of Department letter
6/11/59. For your information the memorandum dated
6/5/59 referred to therein contained data set forth
in your teletype dated 6/4/59 re Anti-Fidel Castro
Activities. A copy of the 6/5/59 memorandum is enclosed.

In view of the possible violations referred to in the
Department's letter, you should immediately institute an
investigation aimed at obtaining legally admissible evidence
which would prove the allegations. Obtain signed statements
wherever possible. You should submit your recommendations
relative to making PSI Vernancio Lopez Sosa and PSI Robert
Williams available to the Department as witnesses in this matter.
In the event you recommend against such action, you should
endeavor to develop other sources who will be able to testify
to the same information. You should endeavor to determine the
identities of those involved, the source of their funds and
the details of their activities. Endeavor to determine if the
planes to be utilized in this matter were actually obtained
and disguised as indicated.

You should consider an interview with Jaffee
concerning the allegation that he flew arms from Miami to Cuba,
it being noted that Jaffee has furnished information to your
office in the recent past. You should also endeavor to obtain
independent verification of the allegation that he made such
a flight. Consideration should be given to an interview with

Erie Peacock in view of the allegation that Pozo and Masferrer reportedly are recruiting American pilots through him and with Robert Daut to determine the type of work he does for Masferrer. You should consider utilizing a suitable pretext to interview William Johnson and Chester Moler concerning their trip to Cuba providing this can be done without jeopardizing your informant who flew these individuals to Cuba. It would appear that such interviews are feasible as both reportedly made drawings and talked to many people while in Cuba about military installations. Efforts should be made to locate and review Johnson's bank accounts since he allegedly receives money for the anti-Castro movement which he delivers to Pozo. You should also locate and review the bank accounts of Pozo in an effort to determine the source of his funds and whether he receives money from Johnson.

In view of the importance of this matter, you should submit a report at the earliest possible time.
