AT BEL AIRE, FLA.

1. Will spot check the residence of LA ROCCA at this location in an effort to determine whether it is occupied and whether any vehicles bearing Pennsylvania registrations are in the immediate neighborhood. It should be noted that informants have advised that LA ROCCA returned to Pittsburgh during the second week of April, 1964, but may have left someone living in his house.

2. Will review all toll calls made from the LA ROCCA residence at Bel Aire and will set them forth for proper identification.

PITTSBURGH

AT PITTSBURGH, PA. (ALLEGHENY COUNTY)

1. Will follow and report the activities of LA ROCCA in accordance with Bureau instructions and will specifically attempt to develop new sources of information which will be able to give an even more complete coverage of these activities.

2. In relation to the aforementioned lead, will specifically attempt to develop intensive coverage at the Mikfon Jewelry Company in the East Liberty section of Pittsburgh, at which location MIKE GENOVESE and underlings of the LA ROCCA - GENOVESE organization are alleged to hold meetings on a periodic basis.

ADMINISTRATIVE

JOSEPH TOPOLINO, former maintenance man at the Bel Aire, Fla., residence of JOSEPH REGINO, has been contacted by Bureau Agents of the Miami Office, and he appears willing to cooperate by furnishing information concerning REGINO and LA ROCCA. He has advised that he comes from Johnstown, Pa., at which location he operated a beer distributorship which failed. He came

to Florida at the invitation of REGINO and he and his wife lived at the REGINO residence for a few years. TOPOLINO was separated from his wife and moved out of the residence about one year ago, but he still sees her periodically. He said that his wife, although not related to the REGINO family, remains loyal to the family members.

TOPOLINO advised that about six months ago, REGINO accused him of stealing some tools and struck him in the face. He did not retaliate because he did not wish to get into trouble, but he has no loyalty to REGINO. He advised that under no circumstances will he ever testify to anything he says and he does not wish his contacts with the FBI to become known to anyone. He will furnish whatever information he can but admitted that this will be limited.

Information furnished by TOPOLINO appears in this report under a T symbol but it was deemed advisable to identify him more fully in the administrative section.

SA ROBERT A. VOEGE, who has handled the LA ROCCA investigation since its initiation following the conference at Apalachin, New York, was assigned to the Bureau Applicant Program at Johnstown, Pa., from 1/15/64, through 4/24/64. Because of this, the period of this report has been extended longer than usual. The investigation has been kept current, however, through numerous interoffice communications and through extensive informant coverage which has pinpointed the location of LA ROCCA on an almost daily basis.
