PG T-4 advised that he knew JOHN SCARDINA by reputation only from 1956 to 1959 as a racketeer in the Farrell-Sharon area of Pennsylvania. He stated, however, that he knew the wife and daughter of SCARDINA personally and advised that the godfather of the daughter, whose name if MICHELENE, is SALVATORE MARINO, a racketeer who originated in the same area.
