It is noted that GRAMATGES, during interview, declined to give the location of captioned organization's base of operations outside the United States and flatley stated that the organization was receiving no help and wanted no help from the United States Government. He also indicated that his superiors in the organization were cognizant of his contact with the FBI. 🗶 🕽 The enclosed LHM is classified "Confidential" because GRAMATGES requested that his identity not be made known outside the United States Government circles and also because Miami letter and LHM dated 3/29/66 indicated that the United States Army Field Appraisal Detachment, Miami, Florida, had an operational interest-in TONY CUESTA and about 15 other members of Comandos L.
