On 5/5/69, source advised that CARLOS MARCELLO had received a letter from CONNIE CAROLLO requesting money from CARLOS and he instructed his secretary to make out a \$500 check to some church or religious order and had her send it to the CAROLLOS. He then tore up the letter from CAROLLO so source did not have a chance to examine it.

On 5/15/69 source advised that on 5/13/69 CARLOS MARCELLO had gone to Baton Rouge, La., for an important meeting with unknown individuals and source does not know the purpose for this trip. He noted that the Governor had signed DALTON SMITH's extradition order to California yesterday and NOFIO PECORA had requested CARLOS to intercede for DALTON SMITH to prevent extradition, and this may have been the reason for the trip. However, CARLOS told source that he only called MARSHALL BROWN and BROWN told him there was nothing he could do for SMITH.

Source advised that yesterday CARLOS went with his CPA, JOHN CONNALLY, to meet with some people about the prospective purchase of Commander's Palace.

Source advised that they are making a deal with the successors to the Churchhill Farms Estate to buy approximately 500 acres of land adjacent to Churchhill Farms, and all of the heirs stock in Churchhill Farms Estates were \$100,000. CARLOS is getting a loan from WILSON ABRAHAM for \$100,000 which amounts to advance payment by WILSON ABRAHAM of some 200,000 odd dollars, which represents the purchase price of a piece of land that he recently bought from CARLOS MARCELLO.

Source advised that JACK WASSERMAN has reservations at the Royal Orleans Hotel for 6/1/69 and has requested a complete transcript of the comments made by KOHN and NEFF at the Metropolitan Crime Commission luncheon, as he is contemplating suing one or both.
