## HEADQUARTERS CITY

### A. ORGANIZED GANGS

In the past six months the following contacts have been had frequently with the Chief of Police CARL F. HANSSON of the Dallas Police Department, Captain GEORGE DOUGHTY, Special Services Bureau of the Dallas Police Department (vice and rackets), Deputy Chief M. W. STEVENSON in charge of the criminal investigation division of the Dallas Police Department, PCI H. P. WHITE, DL 53-C, DL 40-C, DL 33-C, DL 71-C, DL 73-C. Also frequent contacts have been had with Sheriff J. E. "BILL" DECKER of the Dallas County, ~~FORREST~~ KEENE (NA), University Park Police, Dallas, District Attorney HENRY WADE, Dallas County District Attorney's Office, DAN REYNOLDS, Director of the Dallas Crime Commission. These criminal informants and law enforcement heads all advised they know of no organized gangs in the city of Dallas or Dallas County.

### B. INDIVIDUAL RACKETEERS AND MOBSTERS

In the period of the past six months in contact with the above mentioned informants and law enforcement officers who are in a position to evaluate racketeers and mobsters in this area, all advise that due to strict law enforcement it has been very difficult for these individuals to operate successfully in this area.

Dallas Police Department No. 23051

These individuals continue to reside in Irving, Texas, which is a suburban village of the city of Dallas. The activities of BASS, CASCIO, and POPE are observed frequently by the Dallas County Sheriff's Office and Dallas Police Department. Above informants and police officers advised although these individuals are engaged in burglaries, the police have not been able to obtain sufficient evidence to bring them into court.
