ADMINISTRATIVE DATA

The information that POPE was in West Texas was originally obtained by the El Paso Office from DON VARNEL JONES, a former Dallas pimp, who is presently under development by the El Paso Office as a PCI. The El Paso Office has requested that JONES' identity be kept confidential.

The information which led to the location and apprehension of PEGGY ANN FRYE was obtained 8-26-59 by Bureau Agents from Mrs. RUBY JELSEN, FRYE's mother. She has requested that her identity be kept confidential.

The El Paso Office should be credited with the apprehension of a Bureau fugitive, PEGGY ANN FRYE, at Midland, Texas, on 8-26-59.
