Reference also Bulet of 3-23-61 with which was furnished a copy of San Antonio airtel of 3-10-61 and two copies of San Antonio letterhead memorandum of the same date.

EXEMPT

Information supplied by the subject concerning anti-FRANCO activities as set forth in the two San Antonio letterhead memoranda of 2-17-61 and 3-10-61 has not been furnished to Spanish and Portuguese sources because it appears that subject may have been withholding information with regard to anti-FRANCO activities or with regard to the personal activities of subject while in Spain and Belgium. It has been rather definitely established that subject was in contact in Madrid in 1960 with Colonel RAMON BARQUIN LOPEZ and with OSCAR ORAMAS, yet on interview the subject denied any such contacts. From the information furnished by the Belgians to the Paris Office, it appears rather obvious that he had a rather definite mission in connection with DRIL activities in Lieges, Belgium, yet he endeavored to pass this off as purely a casual matter.

Copies of San Antonio letterhead memoranda of 2-17-6and 3-10-61 have been furnished to the OSI here because of OSI interest in activities affecting the stability of Spain in light of the fact that several U. S. Air Force Bases are located here.

As the Bureau is aware, <u>CARLOS BARRINAT GONZALEZ</u> POSADA, aka <u>CARLOS BARRINAT</u>, a former member of the Cuban G-275 setup, is in Madrid and is <u>Cooperating with the Madrid Office</u> at the present times. Separate cases have been opened in the Madrid Office on the individuals who accompanied the subject into exile to the United States, with the exception of the fishermen who handled the three boats and who are of no apparent *I.c. By separate communications to the San Antonio Office through the Bureau, the San Antonio Office is being requested to furnish photographs of these individuals, if same are available, inasmuch as BARRINAT has indicated that while he on occasion has difficulty remembering names, he never forgets a face. Upon receipt of the photographs, they will be exhibited to BARRINAT for the purpose of ascertaining what information he may be able to furnish concerning the individuals, it being noted that almost without exception subject recommended them as being anti-CASTRO in sympathies and reliable.

Two extra copies of this letter are attached for forwarding by the Bureau to the San Antonio and Miami Offices for information.
