On June 14, 1962, Colonel Rene Tallichet, Central Intelligence Agency (CIA), made reference to National Security Agency (NSA) message 3/0 (CUD) T536-62, dated June 7, 1962. This deals with a communication between

concerning the granting of a Cuban visa to a U. S. citizen named George Spellmeyer, owner of the fishing boat "Teresa y Julia."

Colonel Tallichet advised that on June 14, 1962, CIA had received sensitive information covering communications within the Cuban Government. One of these intercepted communications has disclosed that the aforementioned fishing boat was leaving Havana for the Isle of Pines (location of Cuban prison). Tallichet pointed out that it appears most unusual that a fishing boat owned by a U. S. citizen would be involved in such activity.
