On 11/24/60, WF 1133-50 advised that subject contacteds) Dr. ARMANDO FLOREZ, Cuban Charge do Affaires ad interim, from Baltimore, Maryland, to advise that he had agreed to meet and talk with Ambassador QUINTIN PINO MACHADO and DIMAS CID, Cuban Attache, at 5:30 p.m., on 11/24/60, in Baltimore. Upon arrival at the appointed place, the office of the physician brother of his fiancee (DIANA LUZ BERRIOS), MARTINEZ found a note left by PINO indicating that the latter and DIMAS CID had been there but had departed since subject had failed to make an appearance. MACHADO indicated to FLOREZ that he was very interested in speaking with these "two comrades" and asked FLOREZ to tell them to call him on the night of 11/24/60 or on 11/25/60, at the telephone number AT 8-3185 in Baltimore. In discussion with FLOREZ, the latter commented to subject that everybody else at the Cuban Embassy, including FLOREZ, himself, are "comrades"
