INFORMANT

On November 5, 1964, LUIS ROSADA, a Cuban exile associated with an anti-CASTRO group named JUNTA REVOLUCIONARIA CUBANA, and who resides at 750 N. W. 15th Street, Miami, Florida, advised as follows:

He recently learned from SERGIO MARTIN VIDAL, Miami telephone number FRanklin 1-6967 (address not recalled), that MARTIN VIDAL had seen FERNANDO GALAN CAPILLO in Brooklyn, New York, two or three months prior to their conversation.

According to MARTIN VIDAL, FERNANDO GALAN CAPILLO is a Cuban Communist employed as a merchant seaman. POSADA did not possess details as to how GALAN came to be described as a Communist. POSADA speculated that GALAN entered the United States as a seaman.

An article in the Cuban exile newspaper, "Cuba Libre", date not indicated but possibly September 2, 1960, related that FERNANDO GALAN CAPILLO, ERNESTO RERDOMO CONTRERAS, and JUAN ANTONIO MAS of G-2, had been arrested in Honduras because they distributed Communist propaganda from Cuba. Also arrested was FELIX EDUARDO BELLO (or BELLA) a cousin of "CHE GUEVARA, from whom five false passports were confiscated. The four arrested individuals were to be deported.

On December 21, 1964, SERGIO MARTIN VIDAL, 244 S. W. 9th Street, Apartment 20, Miami, Florida, advised as follows:
