SUBJECT: JFK Assassination Records: Release of CIA Information
(U)

The Department of State supports the CIA's request that the President exercise his authority to postpone disclosure of any document related to the assassination of President Kennedy which would implicate high [redacted] officials in joint intelligence operations against foreign embassies in [redacted]. The Department shares the CIA's concern that such disclosure could make [redacted] officials reluctant to engage in joint intelligence activities. The Department also shares the concern that disclosure would lead to a curtailment or complete shut off of information from several on going sources. (S)

In addition, release of this information would damage US relations [redacted] and it could also have unfortunate repercussions for US relations with Russia, especially during this heated period of their presidential election campaign. Finally, as a matter of policy the US government does not confirm that it engages in the monitoring of telephone calls from diplomatic premises here or abroad. Release of this information could subject the US [redacted] to strong criticism from foreign governments. (S)
