4. REPORT OF FINDINGS

(266) On 22 October 1960, a check of the records maintained by Berlin Station, 513th MI Group, APO 742, US Forces, concerning Anne Marie Egretaud, born 27 March 1902 in Gueret, France, revealed substantially the following information:

On 7 June 1960, French authorities in West Berlin UU9220, Germany, requested CIS coverage be initiated on Fred Saldern, Schaper Strasse 22, Berlin W15 (British Sector), a suspected letter drop for Doctor Anne Marie Rene Egretaud and other residents of East Berlin. CIS was initiated on 10 June 1960.
