- 1. (C) Subject's name was brought to the attention of this Station by Mr. John Lucy, CAS, on temporary duty with CAS Team, San Juan, P.R. Lucy stated that recently he had interviewed subject in Washington, D.C. During the course of the interview, subject withdrew a business card from his wallet stating that the name on the business card was that of an OACSI representative posing under commercial cover in San Juan, P.R.
- 2. (6) Lucy described subject as a Cuban refugee who posed a threat to their operations because of his violence, and the possibility that subject might attempt to cause a demonstration which would be embarrassing to their interests. or the U.S. Government.
- 3. (C) Organt, 501, 502, and 504 state that name is familiar, but no personal association with subject is claimed. 504 believes that subject was associated with Autoboat. Organt recalls subject as a fund raiser for a Cuban refugee organization who may have been associated with an OACSI project.
- 4. (6) Lucy has been advised that we do not have contact with subject. He has also been given the G2, AntCom file on subject. Lucy was specifically told that we desired to know what the name of the individual was that subject alleged was known to him as an OACSI representative under commercial cover in San Juan. Lucy promised to do this upon return to Washington. D.C.
- 5. (c) The purpose of this D/F is to advise you of the above, and to insure that Lucy complies with our request at a later date.
