CARLOS PRIG SOCARRAS INTERNAL SECURITY-CUBA

On September 13, 1962, a confidential informant, who has furnished reliable information in the past, asvised that on that date, Carlos Prio Socarras, former President of Caba, contacted Rome Fiallo, of the Dominican Bobassy, Vashington, D. C. Prio stated that he was going to be in Vashington during the following week, and in view of the aggravated Cuban problem, was thinking of issuing a statement in Vashington which he desired to have Fialle translate. Fiallo, after some reluctance, stated that he would do what he could for desecracy, but that he had intended to leave Washington on the following Sunday to spend a week in the Dominican Republic. However, he agreed to change his travel reservations so as to leave Washington on Saturday, September 15, and to pass through Miami where he was to be net by Prio.

According to the June, 1962 issue of the "Diplomatic List," published by the United States Department of State, Rene Fiello is Minister-Counselor of the Dominican Embassy. 75)
