As has been proviously reported, ex-President CABLOS PRIO SOCARRAS of Cuba and his family arrived at Vigo, Spain, on August 17, 1960, and departed immediately thereafter for Santingo de Compostela, Spain, where he resided at the Hestal de los Reyes Católicos.

On September 16, 1960, a confidential source abroad advised that PRIO and his family departed Santiago de Compostela by automobile on August 24, 1960, for Eadrid, where they stopped at the Hotel Castellana Hilton.

Gource said that PRIO engaged in no political activities or political conversations during the time he was in Santiago de Compostela, but that he did make it understood that although he had aided FIDEL CASTRO in overthrowing the DATISTA regime, he is not in conformity with the policies being followed by CASTRO.
