(SUBJECT Interview) On 25 February 1963, Epifanio ROMERO-Delgado, Cuban pre inductee, who resides at 135 SW 18<sup>th</sup> Court, Miami, Florida; permanent mailing address c/o Gustavo Acosta, 1140 SW 9<sup>th</sup> Street, Miami, Florida; employed in a shoe factory in Hialeah, Florida, name and address of shoe factory unknown to SUBJECT, ~~###~~ social security number is

, was interviewed in the Spanish language at the U.S. Armed Forces Main Induction Station, Coral Gables, Florida, concerning HIS arrests, and HE stated substantially as follows:

On 20 April 1961, HE was arrested by the G-2, in Finca de la Mar, San Cristobal, Pinar del Rio, on suspicion of working with the anti Castro elements there. HE was suspected because of the company HE kept, people who were anti Castro, and that HE did not socialize with those who were in favor of Castro. HE was held 5 days by the G-2, during this time HE was interrogated, a number of times, and held without food or water. HE was then sent to the jail in Consolacion del Sur, Pinar del Rio, Cuba where HE was held for 13 days. HE was then released without trial, lack of evidence.

SUBJECT stated this was the only time HE has ever arrested; and that ~~apart~~ other than what was mentioned here in, HE has never been held, arrested, detained or imprisoned for civil, political or military reasons.
