(LOCAL AGENCY) On 2 December 1966, the records of Casual Source A-16, Oakland, California, were checked concerning SUBJECT and revealed the following information:

An editorial entitled "Some US Children Review a Special Exhibit" contained in the 27 January 1954, edition of the People's World, described how school children in San Francisco, California were shown a film of Russian school children. After the film one student, David Fromer, age 11, not further identified, who may or may not be identifiable with SUBJECT asked the question "Why can't we send our pictures over for them to see?".
