4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 28 October 1968, a physical check was conducted at 1435 Ogden Avenue, Bronx, New York, New York, in an attempt to locate Juanita Reyes, listed character reference of Manuel MARTI, with negative results. A check of the names on the mail boxes in the apartment building located at the above address failed to reveal any listing for Reyes. The wife of the building superintendent, name not furnished, was contacted and she stated that she had never heard of Reyes and there was no one by that name residing in the building.

AGENT'S NOTES: SUBJECT'S SPH, dated 1 August 1968, reflects the above address for Reyes. A courtesy letter addressed to Reyes was returned by the Post Office Department with the statement "Addressee unknown".
