4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 4 November 1968, an attempt was made to contact Juanita Reyes, 940 East 173rd Street, Bronx, New York, who might be identifiable with Juanita Reyes, 1435 Ogden Avenue, New York, New York, listed character reference of Manuel MARTI, with negative results. There was no one available at Reyes' residence. A courtesy letter was left at the residence with the request that Reyes contact the undersigned for an appointment.

AGENT'S NOTES: An earlier attempt to contact Reyes at the address furnished on SUBJECT'S SPH, dated 1 August 1968, revealed that no one by that name was known at the address.

(LISTED CHARACTER REFERENCE) On 10 November 1968, an attempt was made to contact Juanita Reyes, 940 East 173rd Street, Bronx, New York, who might be identifiable with Juanita Reyes, 1435 Ogden Avenue, New York, New York, listed character reference of Manuel MARTI, and who had failed to respond to a courtesy letter left at her residence on 4 November 1968, with the following results:

Alberto Reyes, a relative of Juanita Reyes, was contacted and stated that he had never heard of SUBJECT, and that Juanita Reyes had returned to Puerto Rico over one year ago. He further stated that she had never resided at 1435 Ogden Avenue, New York, New York.
