4. REPORT OF FINDINGS

(LISTED CHARACTER REFERENCE) On 14 November 1968, a postal removal check was conducted at the United States Post Office, 558 Grand Concourse, Bronx, New York, with the assistance of Mr. Auteri, Postal Inspector, concerning Aleanso Ortiz, 810 Hunts Point Avenue, Bronx, New York, listed character reference of Manuel MARTI, with the following results:

Source stated that there was no removal on record for Aleanso Ortiz from the aforementioned address; however, there was a removal for an Andre Ortiz from that address to 1749 Grand Concourse, c/o Rivera, Apartment 3J.

(LISTED CHARACTER REFERENCE) On 14 November 1968, Angel L. Rivera, Parole Officer, who resides at 1749 Grand Concourse, Bronx, New York, contacted the undersigned telephonically in response to a courtesy letter at his residence. Rivera stated that he was not acquainted with Aleanso Ortiz or Manuel MARTI, and that the postal removal for Andre Ortiz from 810 Hunts Point Avenue, Bronx, New York, to his address was for his mother-in-law, Andre Ortiz, who recently returned to Puerto Rico.
