1 (EMPLOYMENT) On 27 October 1958, Paul Wolfson, accountant, and former co-owner of Hilltop Lodge, Sylvan Lake, New York, with residence at 424 Marlborough Road, Brooklyn, New York, declined to be interviewed at his residence, but furnished substantially the following information spontaneously in telehonic contact:

SUBJECT performed HIS duties well, got along well with guests at Hilltop Lodge, and left in August 1953, at the end of the 1953, Summer season. Source knew nothing further concerning SUBJECT'S background, associates, or loyalty to the United States.

Source called the 108th CIC Group, and furnished the above information. The call was in response to a letter left at his residence requesting an appointment for interview.
