(S) On 1 February 1972, an attempt to interview the following persons regarding an incident of possible Counter-Intelligence interest at C Team, 66th USA Artillery Detachment, Datteln (IC8424), Federal Republic of Germany, APO New York 09078, met with negative results.

John C. Stelpflug, SP5, JFK Act 5 (g) (2) (D) formerly of C Team, 66th USA Artillery Detachment, had departed the unit on 7 January 1972. Stelpflug had returned to the United States to be discharged from the US Army. Stelpflug left a forwarding address of W164 N9423 Water Street, Menominee Falls, Wisconsin.

John P. Lukasik, SP5, JFK Act 5 (g) (2) (D) formerly of C Team, 66th USA Artillery Detachment, had departed the unit on 23 January 1972 for assignment at the USA Air Defense School, Fort Bliss, Texas.
