1. TANZANIAN FOREIGN OFFICE HAS CONTACTED DAR EMBASSY WITH REPORT THAT TANZANIAN POLICE ARE DETAINING GEORGE LESLIE R I C E , AKA GEORGE LORENZO M A T T H E W S , AKA GEORGE EDWARD W R I G H T, DPOB. 21 MAY 1944, BIRMINGHAM ALABAMA.

2. FORNOFF OFFICIAL CLAIMS POLICE PICKED UP SUBJECT ON UNDETERMINED CHARGE BUT UNDER INTERROGATION HE SIGNED STATEMENT THAT HE WANTED ON THEFT WARRANT IN U.S., AND ON BASIS THAT ADMISSION TANGOV MIGHT CONSIDER EXTRADITION IF EMBASSY COULD IDENTIFY HIM AND WISHED TO PURSUE CASE. THIS IS COMPLETE REVERSAL OF FORMER TANZANIAN POSITION.
