

H.S. GITIZEN, CONVICTED ARMS DEALER WHO MAINIAINS CLOSE TIES TO KNOWN UNDERWORLD FIGURES.

1. COM (HOBINSON), A BLACK PANAMIAN WHO RESIDED IN NASSAN, RAMAMAS, RECENTLY HAS MADE FOREIGN ENOUNDES INTO THE POSSIBILITY OF HEPIND ARMED MERCENARIES TO BE HEED IN AN ATTEMPT TO OVERTHROW THE SOUTHMENT OF PRIME MINISTER LYNDON O. (PINDLING). DURING A MEETING WITH NON-BAHAMIANS, WHO MAVE CLOSE THES WITH FOREIGN APME DEALERS, THAT TODY PLACE OUTSIDE OF THE BAHAMAS ROBINSON DTATED THAT HE REPRESENTS ELEMENTS OF THE BAHAMAS ROBINSON DTATED THAT HE REPRESENTS ARE AVAILABLE FOR ACTION AGAINST IME EAMAMIAN GOVERNMENT.
