1. ANSAIL-1 GAVE MEMO FROM ANSUPER-1 TO CASE OFFICER NIGHT 28 OCTOBER CONCERNING COMMO WITH AMDAMP-3. FOLLOWING SUMMARY:

[EUGENIO DOMINGO AMADOR] PEREZ (SUBJ UFGA 8557) IS CLOSE TRUSTED FRIEND ANSUPER-1. SOME TIME AGO WHILE IN MEXI AMDAMP-3 ASKED [AMADOR] SERVE AS LETTER DROP FOR SW MAIL TO BE RECEIVED FROM CUBA, MAIL TO APPEAR AS INNOCENT LOVE LETTERS. UPON RECEIPT THESE LETTERS [AMADOR] WAS TO MAIL THEM TO [OSCAR E. SOCARRAS, 1501 COLLINS AVENUE, MIAMI BEACH, FLORIDA. [AMADOR] RECEIVED SEVERAL LETTERS AND SENT THEM ON AS AGREED. LETTERS CEASED COMING BUT RECENTLY [AMADOR] RECEIVED AN ENVELOPE (MAILED 3 OCT) FROM [LUIS DOMINGUEZ, G. GONZALEZ NUMBER 480, R. ROOSEVELT, PUERTO RICO. THIS ENVELOPE CONTAINED ENVELOPE MAILED TO THAT ADDRESS FROM CUBA. ENVELOPE FROM CUBA CONTAINED RCA 301 PROGRAM CARD WITH SIX BLUE PENCIL MARKS. [AMADOR] ALSO RECEIVED LETTER FROM [SOCARRAS] ON RANOCROFT HOTEL AND HOTEL STATIONERY, COLLINS AVENUE AT FIFTEENTH, MIAMI BEACH, DATED 13 OCT. [SOCARRAS] LETTER MENTIONS EARLIER LETTER OF 19 SEP IN WHICH [SOCARRAS] ASKED [AMADOR] OBTAIN ADDITIONAL ACCOMODATION RESEMBLES MEXI SINCE THOSE [SOCARRAS] ALREADY HAD HAVE BEEN USED

UP. GOCARRAS LETTER OF 13 OCT ASK WHETHER <sup>04</sup>[AMADOR] HAS RECEIVED ANY RECENT CORRESPONDENCE ADDRESSED TO <sup>04</sup>[ENRIQUE AMADOR PEREZ], <sup>08</sup>[ALVARO OBREGON 40, DEPTO G, COLONIA] ROMA, MEXICO D.F. (THIS IS APPARENTLY INQUIRY ABOUT ENVELOPE WHICH CONTAINED RGA CARD).

2. IN CONVERSATION WITH ANSUPER-1 <sup>04</sup>[AMADOR] INDICATED THAT AMADAMP-3 HAD TOLD HIM HE WAS GOING TO UNITED STATES. WHEN ANSUPER-1 INFORMED HIM AMADAMP-3 IN CUBA <sup>04</sup>[AMADOR] BECAME SUSPICIOUS AND REVEALED ABOVE STORY ASKING THAT ANSUPER-1 CHECK INTO MATTER TO DETERMINE IF <sup>04</sup>[AMADOR] BY SERVICES AS AMADAMP-3 COMMO LINK IS INVOLVED IN ANTI-CASTRO OR PRO-CASTRO OPERATION.

3. STATION NOW HAS POSSESSION OF RGA CARD, ENVELOPES FROM CUBA AND PUERTO RICO, AND GOCARRAS LETTER OF 13 OCT. <sup>04</sup>[AMADOR] UNITS THESE RETURNED WITH MATTER CLASSIFIED.

4. PLS NOTE ANSUPER-1 LET AMADAMP-3 AGENT STATUS. STATION ALSO IN CARE ABOUT THIS AMADAMP-3 TO <sup>04</sup>[AMADOR] TO <sup>04</sup>[GOCARRAS] COMMO LINK. IS THIS A COMMO WAVE OPERATION? WHO IS GOCARRAS? WHAT OTHER OPS IS HE INVOLVED IN WITH THIS COMMO LINK? REQUEST CABLE CLARIFICATION SOONEST. ENDA.
