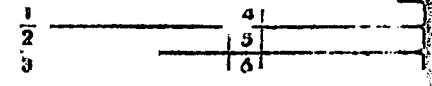

1. BASED TELCON 18 DEC TO SUBJ REF SHE MET BY CO ON 19 DEC. DURING SHORT CONVERSATION DURING WHICH CO STUCK TO [COMMERCIAL]<sup>24</sup> COVER, SUBJ CLAIMED SHE NOT CONNIE, HAD SPENT SEVERAL YEARS IN UNITED STATES, FEARED HER EMPLOY AT [YUG EMB]<sup>6</sup> MIGHT MAKE GETTING VISA DIFFICULT. ALSO EXPLAINED HOW GOT JOB AT [YUG EMB]<sup>10</sup> STORY APPEARS PLAUSIBLE AND DOES NOT INDICATE ANY CONSPIRACIES.
2. AFTER THIS INFO OBTAINED AND BASED ADDED POSITIVE FEATURE OF SUBJ'S CONCERN FOR PAPER VISA, CO ADMITTED HE ACTUALLY ODYOKE OFFICIAL, WANTED HER COOPERATE WITH HIM PROVIDING INFO ON [YUG 10 EMB] ACTIVITIES AND PERSONNEL.
3. BEFORE CO HAD CHANCE MENTION FINANCES SUBJ INDICATED COMPLETE WILLINGNESS COOPERATE. WHEN MONEY OFFERED, SUBJ STATED SHE WOULD WORK FOR NOTHING, BUT WHEN CO REITERATED OFFER, SHE ACCEPTED. AT END OF MEET SHE TOOK 1000 PESOS AND SIGNED RECEIPT IN TRUE NAME.
4. DURING HOUR DEBRIEFING, SUBJ GENERALLY DESCRIBED HER DUTIES WHICH INCLUDE ALL SPANISH CORRESPONDENCE FOR [AMB]<sup>6</sup>, HELP IN PREPARING BULLETIN AND SETTING UP APPOINTMENTS FOR [AMB]<sup>6</sup> AND OTHERS IN [EMB]<sup>10</sup>.  
 CLARING NO ACCESS TO CLASSIFIED MATERIALS WHICH TYPED BY MRS RADOVIC<sup>6</sup>

5. CUBS DID NOT INDICATE ANY KNOWLEDGE OF INTEL ACTIVITIES BUT  
CLAIMS [REDACTED] PERSONNEL, PARTICULARLY [REDACTED], [REDACTED] AND  
[REDACTED] OFTEN CLOSE DOORS ON HER, INDICATING OBVIOUS DESIRE SPEAK  
PRIVATELY.

6. DURING GENERAL DEBRIEFING ON PERSONNEL SUBJ NAMED ALL,  
WAS ABLE TO DESCRIBE GENERAL DUTIES EXCEPT FOR [REDACTED] CLERK  
WHO ACCORDING TO CUBS IS LOCKED IN UPSTAIRS ROOM MOST OF DAY.  
CUBS UNIDENTIFIED BY HER DUTIES OUT WILL TRY DETERMINE DATE.

7. BY END MEET CUBS FULLY AWARE CLANDESTINE NATURE HER  
RELATIONSHIP WITH CO, CLAIMS SHE WILL TELL NO ONE OF HER ACTIVITIES  
ON OUR BEHALF.

8. PRELIMINARY ASSESSMENT IS THAT SUBJ WILL COOPERATE FOR  
FINANCIAL REASONS PLUS A POLITICAL VIEW AND DESIRE PROTECT POPRIME  
VISA. NO SIGNS DECEPTION NOTED. DIFFICULT SAY WHETHER SHE WILL  
TELL FRIENDS, BUT BELIEVE UNLIKELY SHE WILL REPORT TO [REDACTED] SUBJS  
ACCESS APPEARS LIMITED BUT BELIEVE WORTHWHILE RUNNING CASE FOR TEST  
PERIOD TO GET FULL DEBRIEFING AND SEE IF WE CAN DEVELOP HER ACCESS  
BOTH TO POSITIVE AND OPS INFO OF VALUE. PLAN PAY SUBJ LESS THAN  
1000 PESOS PER MONTH DURING THIS PERIOD.

9. NEXT MEET SET FOR 23 DEC DURING WHICH TIME WILL OBTAIN FULL PRQ  
PART I AND COMMENCE FULL DEBRIEFING RE TOPICS INTEREST. PLAN  
WEEKLY MEETS AND POSSIBLE TURN OVER TO OSOLD IN JANUARY IF SUBJ  
APPEARS FULLY RECRUITED AND IF OP APPEARS VIABLE.

10. PLS ASSIGN CRYPT. FOUCHING FULL REPORT.
