FOR MEXI: HQS AHS TO REF SAID: A) AGREE MONT THAT CASTRISTA CONTROLLED FEJU UNACCEPTABLE AS HOST FOR COSEC EVENT B) INTENT OF OCT 11 COSEC LETTER WAS TO OPEN POSSIBILITY MOVING EVENT TO NEW BUT NOT YET DETERMINED SITE, C) COSEC LETTER WAS AUTHORIZED BY SEPT SUPERVISION COMMITTEE (SUP COM) MEETING WHICH BLAMED FEJU FOR FAILURE HOLD EVENT AND TOLD COSEC TO SEEK ANOTHER SITE.

2. FOR PALP: POLL SUMMARIZES HQS UNDERSTANDING LATIN AMERICAN STUDY SEMINAR (LASS) TACTICS DISCUSSED WITH KORONELOS (ITEM A) FIRST STEP REGARDLESS WHETHER LASS ULTIMATELY HELD IS SEIZING INITIATIVE ON SITE IN ORDER HONOR SUP COM DECISION AND OFFER POSSIBLE INVITATION FROM UNFRIENDLY SITE. THIS NOW ESPECIALLY IMPORTANT IN VIEW REF. ONE CHIEF MOST DESIRABLE HOST FROM FEJU CONTROL AND FLEXIBILITY. IN THIS RESPECT KORONELOS AND AVILA (ITEM B) SHOULD CONTACT [REDACTED] BEFORE HIS DEPARTURE EUR. BRIEF HIM ON LASS STRATEGY AND GAIN HIS SUPPORT FOR LASS ONE OFFER INVITATION ACT AS HOST

3. ASSUMING MEXI INVITE LASS CAN BE HELD IF FOLLOWING CONDITIONS SATISFIED

A) PARTICIPATION MINIMUM 7 DEMOCRATIC UNIONS WITH CLEAR EVIDENCE ALL DEMOCRATIC UNIONS WILL BOYCOTT SEMINAR

B) ENOUGH COORDINATION WITH UFUCH TO AVOID THEIR ACTIVE HOSTILITY LASS AND COSBC AND PREVENT FORCING THEM INTO CLOSER ALLIANCE WITH EXTREMISTS ON OTHER WH ISSUES.

C) <sup>6</sup> LIKELIHOOD THAT LASS CAN BE USEFUL FORUM EXPRESSION DEMOCRATIC VIEWS ON SOCIAL ECONOMIC QUESTIONS AND DEVELOPMENT GROUNDWORK NECESSARY FOR ISC TACTICS.

D) EVENT DOES NOT CONFLICT WITH MEKI STATION OPERATIONS.

4. LASS SHOULD NOT BE HELD IF ALL OR ANY PARA 3 CONDITIONS FAIL PERTAIN AND ALSO IF:

A) EARLY EVIDENCE W/LL ORGANIZED EXTREMIST COUNTERACTION (POSSIBILITY OF WHICH RAISED BY VERMENCE FEJU RESPONSE COSBC LETTER REPORTED IN REF.)

B) PALP HQS JUDGEMENT THAT TIME EFFORT NEEDED SUSTAIN HOLDING EVENT BECOMES COUNTERPRODUCTIVE DIVERSION RESOURCES FROM OTHER ELEMENTS HOSPITOME PROGRAM, DEVELOPMENT OF ISC TACTICS, OR HARMFUL MURANK LAYC COUNTERACTION.

5. IF PARA 4 SITUATION UNFOLDS ONE COULD WITHDRAW INVITATION ON GROUNDS INADEQUATE PARTICIPATION (ASSUMING BOYCOTT) OR CONTINUE AS HOST BUT CITE SUNDRY TECHNICAL REASONS REQUIRE POSTPONEMENT LASS.

6. FOR PALP: PARA ONE BRIEFING [ ] WHICH CONFIDENTIAL PALP RECEIPT MEKI COMMENTS, SHOULD INCLUDE CARRIED OFFLINE PARA 2-5 THINKING SO THAT ONE
