SUBJ GRANTED OA SEPT 65 FOR USE BY ANOTHER WOMACE COMPONENT BUT OA CANCELLED FEB 66 SINCE SUBJ JUDGED UNSUITABLE FOR PROPOSED [CONGO] ASSIGNMENT. IN MARCH 67 WODISK REQUESTED LNERGO APPROVAL TO USE SUBJ AS FI SOURCE.
