

MEMORANDUM FOR THE RECORD

SUBJECT: AELADLE/1 Chance Meeting with Petr DERYABIN

1. ⁰³ [James R. Harris] SR officer assigned to the AELADLES has reported that on Saturday, 6 January 1962, he and one of the Security Officers accompanied AELADLE/1 to Ray's Barber Shop in Vienna, Virginia for a haircut. Upon leaving the barber shop at about 1730 hours, they accidentally met Petr DERYABIN who was walking in the opposite direction. DERYABIN recognized AELADLE/1 instantly, and the two shook hands and greeted each other enthusiastically. DERYABIN inquired about AELADLE/1's family, and AELADLE/1 said that they were well and were with him. AELADLE/1 asked DERYABIN if he had married, to which DERYABIN replied that he had, and that as of the day before yesterday he was the proud father of a son. DERYABIN presented a cigar to each of the others. DERYABIN asked Mr. [Harris] "When will all this be in the newspapers?" Mr. ⁰³ [Harris] replied that he didn't know. Mr. [Harris] congratulated DERYABIN on the birth of his son and told him and AELADLE/1 that the street corner was not an appropriate place to talk. The others agreed, and they parted.

2. Mr. ⁰³ [Harris] reports that during the encounter, no one addressed or referred to anyone by name, hence neither DERYABIN nor AELADLE/1 are aware of the other's current name or precise whereabouts.
