

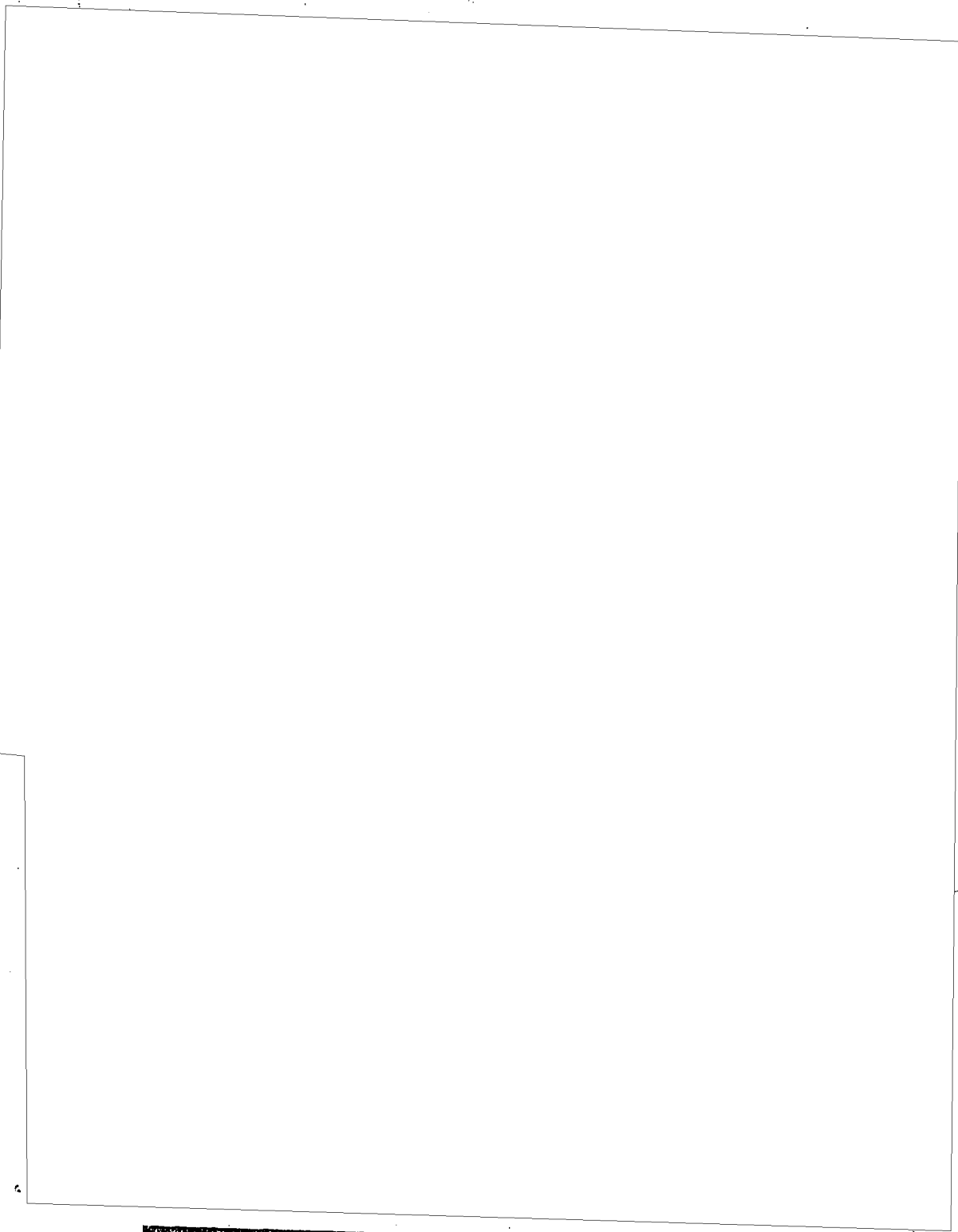
You mentioned that your son, [redacted] might contact me. To date, he has not called so I trust that there has been no need on his part to see me.

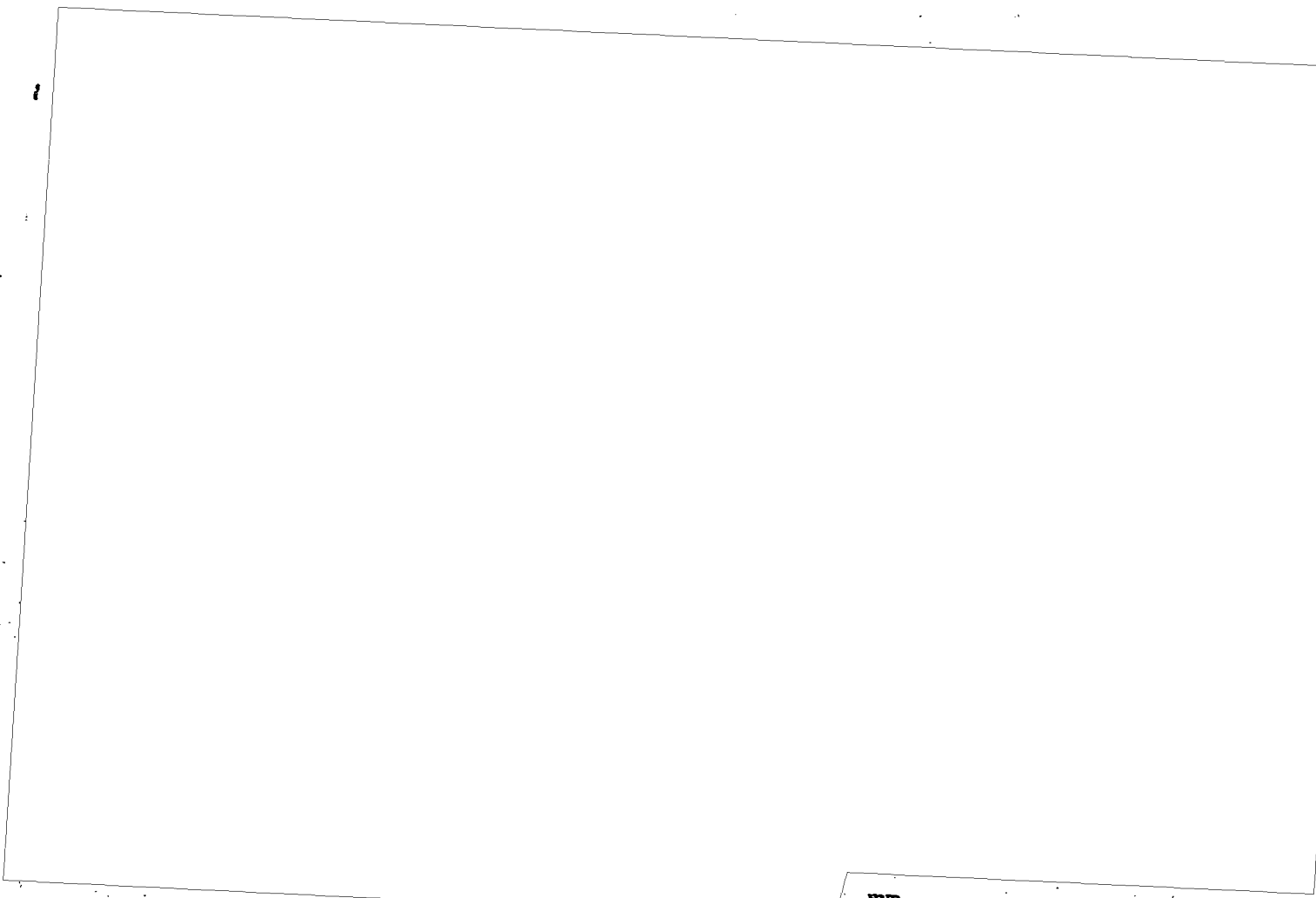
Since I have received no word from you I suppose Rene has not yet answered your letter. Let us hope that we hear from him soon.

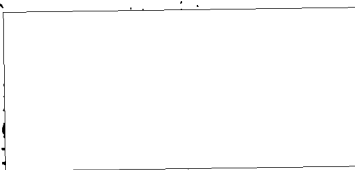

Están estableciendo campamentos militares y aeropuertos en todas partes. Todas las lomas de piedra han sido perforadas para el almacenamiento de armas, a prueba de bombardeo. Miles de rusos han ocupado el país y se les puede ver por todas partes. La represión es salvaje y están preparados para enfrentarse a cualquiera invasión en gran escala. Las anti-aerreas (amatralladoras) conocidas por cuatro bocas han sido sustituidas por lanza cohetes. Palma Soriano, Songo y La Maya están fuertemente fortificadas. La Loma de las Piedras, entre Baire y Jiguani tiene emplazamientos de cohetes. Las conocidas cuevas del Popu, a cinco kilómetros de Baire- hacia la Sierra Maestra- las han convertido en depósito de armas de todos los calibres". (Esta carta salió de la Habana, o Cuba, en la primera quincena de Mayo.)

La carta donde habla de la base de submarinos de Manes se le ha extraviado pero me ofreció buscarla. Mientras tanto, estoy escribiendo al amigo de Holguín invitándole para que me escriba con la mayor cantidad de información.



Muy estimado amigo:

Me complació mucho la llegada de su apreciada carta. Tenía ciertas dudas de que la anterior mía hubiera llegado a su poder. Su carta de los últimos días de Septiembre me llegó solo hace pocos días. Hay demora en la correspondencia por razones obvias. Por su interés en mi estado de salud, le quedo muy agradecido y confío en que el plan que sigo me restablezca prontamente. A veces estoy muy pesimista y considero mi caso crónico y definitivamente incurable. (Se refiere a la situación en Cuba y a lo difícil que resulta el derrotar al régimen fidelco-comunista). Sus palabras de aliento son muy apreciadas por mí. Dadas mis posibilidades trataré de: haciendo uso de la autocrítica autorizada por el partido, o tal vez la crítica sin auto, trataré de describir la situación aquí.

A principios de Octubre pasado tuvimos la visita de la Sra. Flora, terrible huracán que inició su ataque un viernes 3 y nos dejó el miércoles 8, dejando una estela de desolación y muerte. Asotó nuestra provincia y parte de Camaguey durante casi seis días, sin dejar de llover y con vientos de 100 kilómetros por hora. Francamente, creíamos que se había iniciado el segundo diluvio universal. Gracias a Dios, nuestra familia y las de amigos y conocidos no sufrieron daños ostensibles, no así las zonas rurales que fueron barridas por las corrientes, como en Cauto, zonas de Mir, Mayarí, Sagua de Tanamo, Santiago de Cuba, Guantánamo y, en fin, toda la Provincia en sus zonas más bajas. Dada la incapacidad del Observatorio Nacional, la alarma fue emitida demasiado tarde, ocasionando esta irresponsabilidad, por parte de las Autoridades, la pérdida de vidas y animales en sumas astronómicas; según las zonas que conozco y por informes veraces, calculo que sobre 50,000 cabezas de ganado vacuno y otra cantidad igual de porcino se perdieron. Las aves han desaparecido por completo. En vidas humanas me atrevo a asegurar que son más de tresmil. Jóvenes que habían sido llevados a las montañas a recoger café y para otras labores agrícolas, han perecido por centenares, por efecto de los derrumbes de picachos y árboles, así como por las corrientes de agua que bajaban como cataratas. Ahora son conducidos, hacia la Habana, en grandes rastras (big trucks) los despojos de estos infelices, como verdaderos parias, llenos de mugre y harapos, sin alimentos ni consideraciones humanas; sufren y callan pero son incapaces de rebelarse, toda vez que la represión más que brutal es salvaje. Nadie puede imaginarse como es de monstruoso este sistema, que puede resumirse con tres palabras: falacia, propaganda y represión sin límites. Al final se apareció el gran simulador (Fidel Castro) en varios carros anfibios, escenificó un show pre-fabricado y se hizo proclamar "héroe salvador de los campesinos".

Las tremendas inundaciones anegaron los depósitos subterráneos de armas y los túneles que han hecho en las lomas. El aeropuerto (se refiere al de Holguín) sufrió daños de consideración. Una caravana de más de 200 camiones llegó a esta Ciudad anunciando que traían alimentos pero, en realidad, estaban cargados de armas para sustituir a las que fueron dañadas por el Ciclón; temían que se produjera un ataque de los enemigos de Castro, aprovechando las condiciones desastrosas en que se encontraba la Provincia.

Como Ud. sabe, han sido confiscadas las fincas mayores de 5 caballerías, pero lo cierto es que también han ocupado fincas mucho menores, expulsando a los propietarios sin permitirles que llevaran algunas de sus pertenencias. La confiscación de las fincas pequeñas coincidió con el inicio del ciclón, y los ocupantes sin conocimiento de la topografía del terreno, no tomaron las medidas apropiadas para proteger los animales y las cosechas; muchos de estos imbéciles murieron ahogados, pagando con sus vidas su complicidad con los delitos del gobierno, si es que se puede llamar así.

Estas fincas, antes de la confiscación, estaban produciendo bastante, pero ahora han quedado en manos de imbeciles analfabetos, de peones sin instrucción alguna, sin sentido mínimo de sus cargos. Hasta hoy no han pagado los salarios de los trabajadores de esas fincas; también han cambiado el sistema de salarios; a los que ordeñan las vacas le pagan \$0.35 por hora y como no trabajan más de 4 horas, perciben salarios de hambre.- Ahora han impuesto el llamado "racionalismo" en los salarios y abonan al trabaja

dor según lo que produce, exigiéndolo una gran producción por un pequeño salario; así por ejemplo un obrero de una fábrica de zapatos devenga \$5.00 por cada \$25.00; un albañil (obrero de la construcción) gana \$5.00 por cada millar de ladrillos que coloque. (cinco "pesos" cubanos equivalen, ahora, a 50 centavos de dólar americano); es por eso que el mercado negro crece enormemente; los precios en el mercado negro son: 1 huevo, vale \$1.00; una libra de frijoles, \$1.50; una de arroz, \$1.50; 1 libra de café, \$6.00; una de filete, \$10.00. La inflación es incontenible ni con la sanción de fusilamiento. Los sueldos iguales y menores que antes y el racionamiento que es inadecuado no permiten una dieta suficiente en calorías diarias. El mercado negro lo sostienen, precisamente, los miembros de la "nueva clase", que viven como príncipes, en grandes residencias, con varios criados pagados por el Estado y con grandes cantidades de dinero a su disposición; los miembros de la nueva clase son los oportunistas de siempre, hipócritas, simuladores, ladrones y malvados y que son los puntales en que descansa el régimen más abyecto y brutal que se pueda imaginar.

Esta gente son implacables con sus enemigos, y estos son todos aquellos que no se someten al comunismo. El gobierno de ese País (se refiere al Gobierno Americano) si no se dispone a asumir determinados riesgos jamás lograra erradicar este cáncer que amenaza a la América entera; Rusia, ladina y astuta se aprovecha de la conducta honesta de los Estados Unidos, respetuosa de los convenios internacionales, en tanto que ella no los cumple. Tengo la firme convicción de que los rusos no pelean y que usan solo la astucia y los rejugos políticos para ir dominando al mundo, como lo han hecho en el caso de Cuba.

Algunos de los llamados "técnicos rusos" han abandonado nuestra Patria, pero vienen otros y el control de las fuerzas armadas está todavía en sus manos.

Los rusos, cuando se les comina dan un paso atrás pero antes han avanzado; el Mundo Occidental se mantiene en actitud defensiva y ellos lo saben; ellos saben que los Occidentales le temen a la responsabilidad de desencadenar una guerra y se aprovechan de ello; así van minando gobiernos y pueblos; millones de demócratas en el mundo entero opinan que esta actitud defensiva debe ser cambiada por otra ofensiva, antes de que sea demasiado tarde.

Aquí en Cuba se percibe un colapso económico; los desafectos al gobierno son el 90% de la población; pero esto no basta; el gobierno se mantendrá hasta quemar las últimas posibilidades y los rusos lo ayudara mínimamente pero lo ayudan, a pesar de que ahora Fidel Castro como líder nacionalista independiente negándose a firmar el tratado de proscripción de las pruebas nucleares y adscribiéndose al bloque chino.

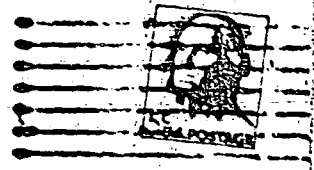

Ahora le transcribo la parte mas interesante de una carta recibida del amigo de Holguin que tiene fecha Agosto 21 y que me fue entregada ayer Sep. 8.-

La carta dice asi: "Comprendo su interes en conocer con detalles la situacion de Cuba.

De acuerdo con mis pobres conocimientos tratare de complacerlo.

Nuestra Patria, querido amigo, no existe; confio que un dia no lejano resurgira de nuevo pues esta situacion podra sostenerse por un tiempo pero jamas por siempre. Considere a Cuba como una base sovietica; la vida normal de la Nacion ha desaparecido; un movimiento continuo de fuerzas militares y de equipos ocupa todo el espacio y el tiempo; es como una peste "verde" que lo invade todo; tambien esta peste verde

afecta la moral de la ciudadania (He says "peste verde" or green pest because all the soldiers were green uniforms -Russian and Cuban soldiers.) En el fondo todos detestan al regimen pero unos por cobardias, otros por estar convertidos en cómplices y muchos por miedo al hambre que impera, lucen como perfectos simuladores. La crueldad del sistema comunista ha destruido los principios de dignidad de gran parte de los Cubanos. La vida de un hombre hoy en nuestro Pais no vale nada, solo unas cuantas balas. Los soldados rojos infectan al Pais; No sabria decirle cuantas son las bases y cuantos los campamentos rusos que existen hoy en Cuba; alrededor de este Pueblo (Holguin) pueden contarse mas de diez; ~~xxxxx~~ creo que el numero de soldados rusos en Cuba ha sido siempre sub-estimado pues estoy seguro que es tres o cuatro veces el numero que el Gobierno oficialmente declara.

En el antiguo aeropuerto de esta Ciudad han construido tal vez la mayor y mejor base aerea de Cuba con pistas de mas de 5 Kilometros de extension; es usada por varios tipos de cazas-sovieticos y esta preparada para aterrizaje de bombarderos pesados; los aviones y arsenales de bombas los guardan en subterranos; tienen grandes defensas antiaereas y rampas de cohetes de "tierra a aire" contra aviones. Todas las alrededores del aeropuerto estan minados para evitar la aproximacion por tierra; el aeropuerto esta asistido por mas de tres mil soldados rusos para cualquier contingencia y son expertos extranjeros quienes lo manejan. Diariamente hacen practicas de bombardeos y antrallamiento detras de la Loma de la Cruz, en las sabanas. La vigilancia en las zonas costeras del Norte de la Isla es constante e ininterrumpida aunque haya mal tiempo. Todas las lomas o cerros de solida textura estan perforados para utilizarlos como almacenes de armas y alimentos; este es un plan que afecta todos los lugares. Grandes rastro penetran en las entrañas de las lomas para descargar y cargar materiales de guerra; para esto han construido carreteras alrededor de todos estos arsenales de las lomas. Todo el litoral, sobre todo en lugares de posibles desembarcos estan minados de trincheras y perfectamente artillados. (He talks about the North Coast of the Province of Oriente and I suppose the situation is the same in all the Provinces).

Ahora han dispuesto la formacion de un Ejercito Cubano y todos los Mili-

licianos tienen que integrarse en el mismo; los que ingresan en este ejército están imposibilitados de volver a la vida civil; me atrevo a calcular en más de 250,000 hombres los que voluntaria u obligadamente forman parte de este ejército cubano; todos poseen armas automáticas y morteros de gran calibre de fabricación soviética o checa. Las armas americanas son utilizadas para introducirlas en los Países de Centro y Sur-América. En Banes existe una Base Naval ligada de aprovisionamiento; allí fabrican los explosivos que conjuntamente con las armas americanas envían en embarcaciones pesqueras a los mares del Caribe; estas armas y explosivos son transbordadas a otras embarcaciones y las llevan como contrabando de mercancías a los Países de Centro y Sur-América. Es de suponer que esto se hace con la complicidad de funcionarios de estos Países Latino Americanos.

Los Cubanos anti-comunistas y anti-Castristas no podemos perder la fe en el Presidente Kennedy pero a veces su política nos parece indecisa y extemporánea. Por aquí no hay indicación alguna acerca de que las fuerzas rusas sean evacuadas de la Isla pues en vez de disminuir han aumentado considerablemente desde el año pasado. Sabemos que ahora se ha intensificado el sabotaje por parte de patriotas importados y dentro pero estas acciones tienen poca efectividad dado el tremendo poder militar que dispone el régimen comunista. La gran mayoría de los Cubanos deseamos tomar parte en una acción final contra el régimen de Castro pero la ausencia de una orientación positiva los contiene".

He suprimido de la carta de mi amigo de Holguín algunos párrafos que en mi opinión no tienen importancia; me parece muy interesante lo que él dice de la Base Naval de Banes cuya existencia parece ser cierta. Como Ud. sabe la Ciudad de Banes está muy cerca de Holguín y hay buena comunicación por carretera entre estos dos Pueblos.

De mi tío de Santiago de Cuba no he tenido noticias positivas y desde Miami me fue imposible comunicarme con él por teléfono.

3- Last Saturday I took some children to Spanish classes which Mrs. Reinolde Nord and Mrs. Ametia Guitart hold once a week. I met Sr. Guitart (L-49) there. Guitart did not look very friendly at the beginning. I presume that some comments I made about political groups in New Orleans got to his ears and he did not think much of them.

A few days before May 20 I was visiting at the Yodos. A man called Jose Enrique Puente was there also. We were commenting about the fact that all of a sudden four or five guys who had been named New Orleans delegates by some Nazi groups were trying to gain strength. Guitart was one of these men (he is supposed to be a close friend of Manuel

Antonio de Varona and represent Varona's group here). I made the comment that if they were seriously considering forming groups here we could and should use Cruzada (the local exile publication) to stop them.

Well, I don't think this is very important anyway. It is possible that Guitart might have not been feeling well Saturday morning, and the rest is all my imagination.

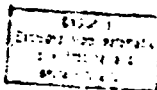
1. Dr. Guitart turned out to be an energetic little man with considerable background in revolutionary/political activities. During the reign of Machado he spent about 17 months in the Isle of Pines prison for his anti-government activities. He has also been active more recently in anti-Batista and anti-Castro activities. After explaining our present needs for current intelligence, Dr. Guitart suggested that we try to establish contact with his uncle, Rene Guitart. Rene is the youngest brother of his father and was always rather close to Dr. Guitart. Rene Guitart is a Santiago businessman. He formerly represented a number of Canadian firms and perhaps other firms as well but now has only one account that Dr. Guitart knows of. This is for the Pillsbury Flour Company of Canada. Rene had business agents in various cities of Oriente province and is very well acquainted with the entire area and, naturally, has a very wide circle of friends and acquaintances. Dr. Guitart said that he had, by indirection, asked Rene to provide him with information about military construction at the port of Banes. He expects to receive Rene's report on the subject in the near future and promised to send me a copy of it. Dr. Guitart felt sure that he could, by indirection, convey to Rene the means for developing the SW system number 99. These directions will be relayed in two letters to be dispatched at one week intervals. A third letter will carry the SW text.

2. Guitart said that he could receive the letters at the home of a friend using the name of one of his friend's daughters. The address is

3. Dr. Guitart wrote the first two letters that same evening and brought them to my hotel Friday evening. Since Dr. Guitart is an energetic man I believe our contact with him will produce more than one recruitment attempt. He spoke of another family that he knows in Holguin and said that he would try to determine their present address and think of ways to contact them.

A continuacion le copio parte de una carta del amigo de Holguin, dirigida a un familiar residente en esta Ciudad :

La Loma de las Piedras, entre Baire y Jiguani tiene emplazamientos de cohetes. Las conocidas cuevas del Peco, a cinco kilometros de Baire- hacia la Sierra Maestra- las han convertido en deposito de armas de todos los calibres". (Esta carta salio de la Habana, o Cuba, en la primera quincena de Mayo.)

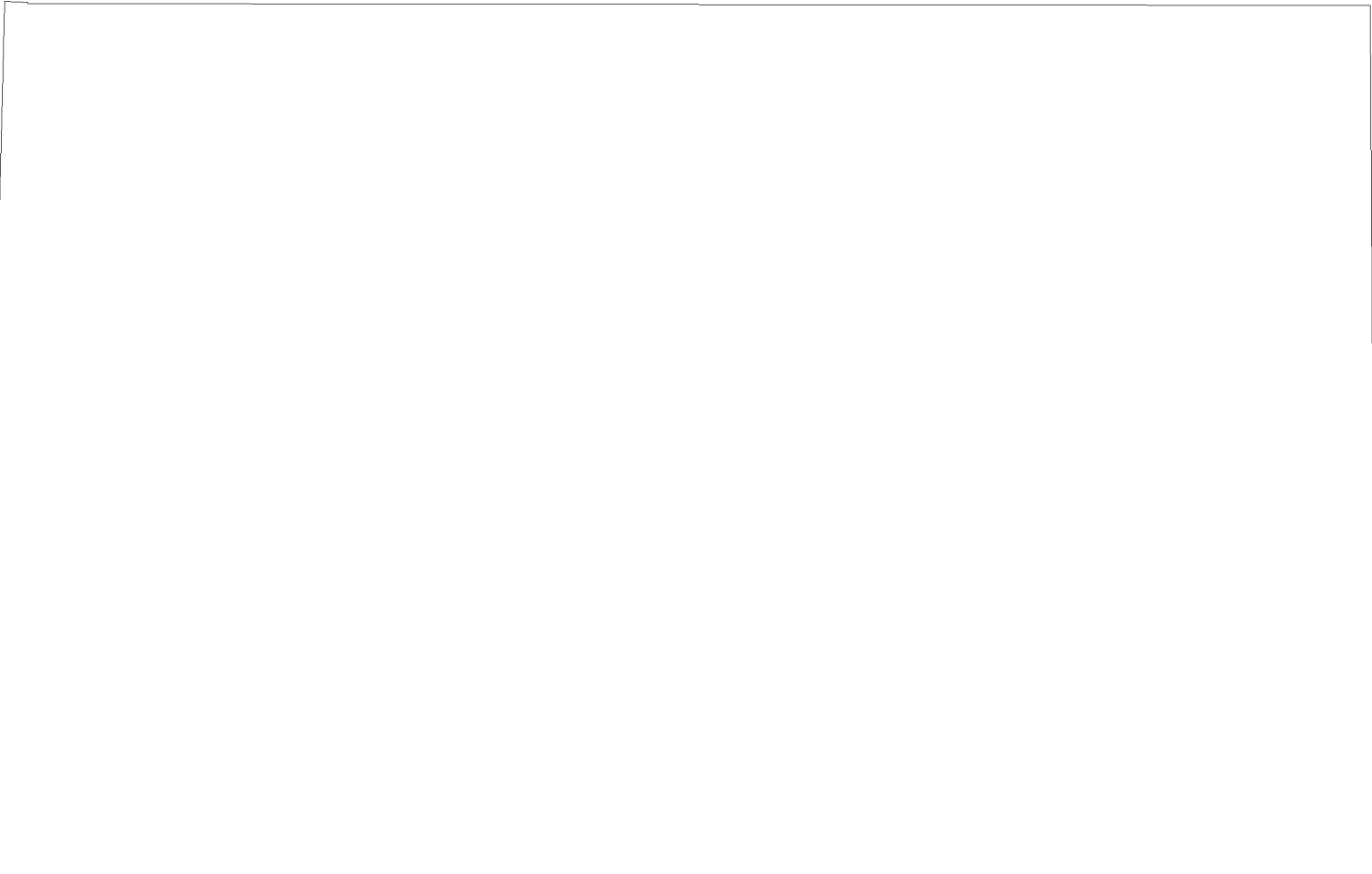

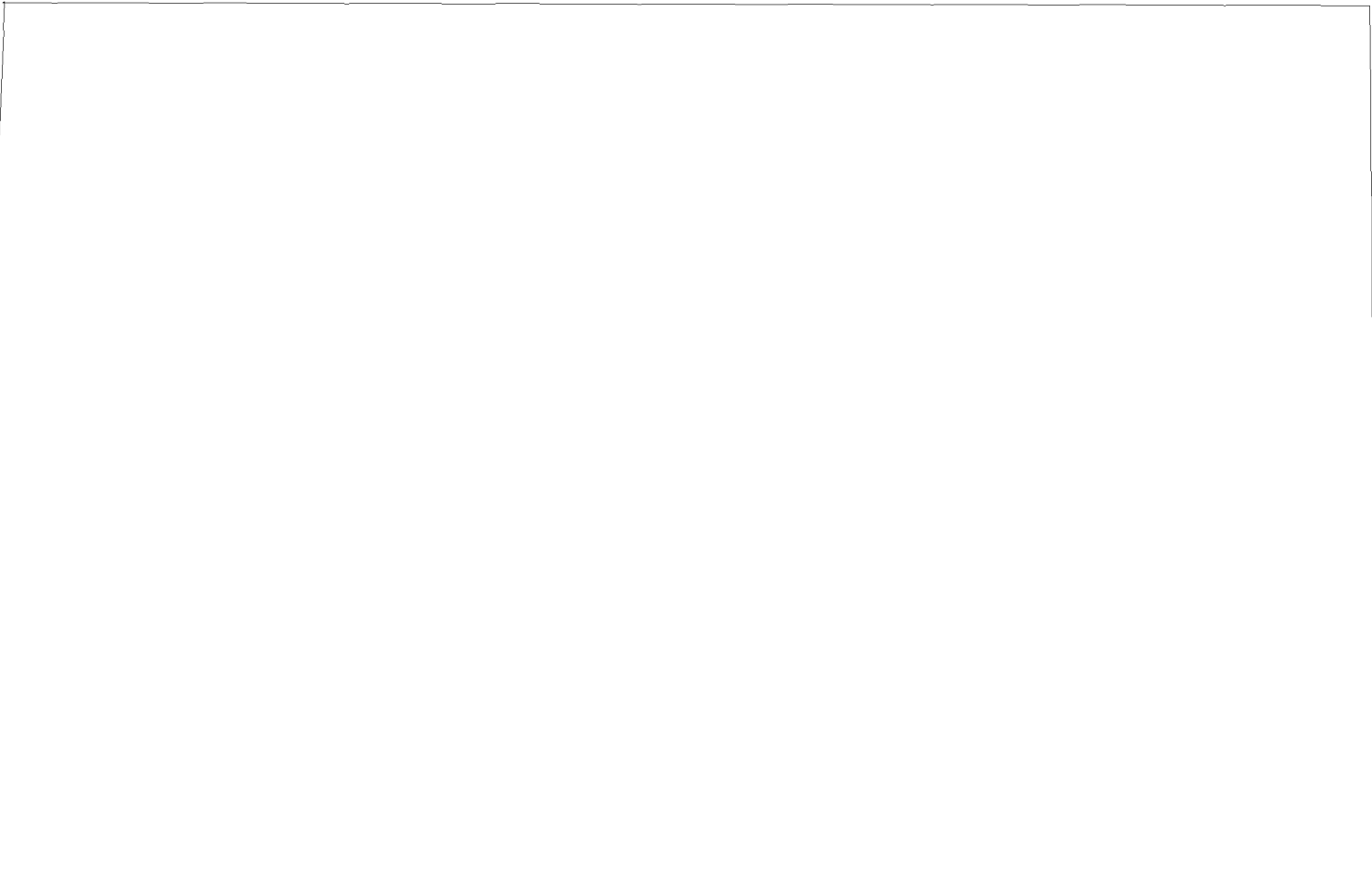

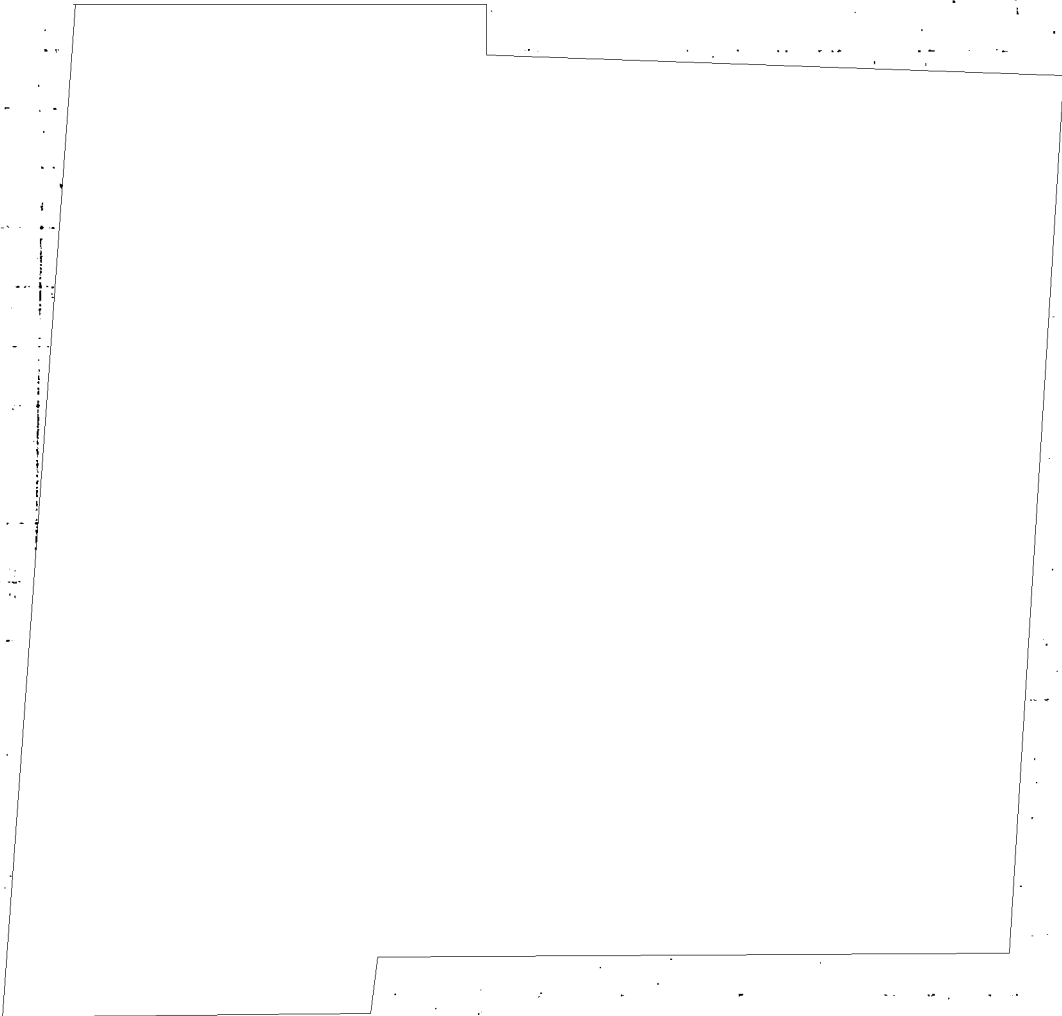

Dear Carl:

This sounds funny but in order to keep the subjects in separate letters I am starting this one. I want to get this one out to give you a chance to look it over before you come. During my visit up north we talked about contacting some professors. I told you there were two or three in this area. I did not have a chance to get close to any of them until last Friday. Here it goes:

Last Friday night (Jan. 25) my wife and I attended a meeting to commemorate the anniversary of the birth of Jose Marti. It was quite cold and not many people attended (the act was not well organized either). After the meeting one of the Cuban couples talked us into stopping at a bar before going home. It happened that Dr. Agustin Quitart (the university professor that looks ~~very~~ surprising) had gone with them to the meeting. What a luck! I accepted with the condition that Dr. Quitart would come along too. He couldn't turn it down. I have been trying to get close to this man for some time and never had the opportunity before. I could not get as much information as I wanted but this is just a start.

Dr. Agustin Quitart was a well known professor of Physics in Havana. He was a professor at the Instituto de la Vibora (a very large public high school in Havana) for many years before becoming a professor at the University of Havana. Dr. Quitart is about 5' 5" and slightly on the heavy side. He has a little bit of grayish hair and a small mustache. He looks to be about 50 years old.

His home address is (from the phone book): 4009 Elba St., New Orleans, La. phone, 82 2-2815. I believe he lives there with his wife, daughter, son-in-law and grand-children. His son stays there some times. I believe he is going to school somewhere. His son-in-law is a Cuban lawyer called

Dr. Quitart is now teaching Physics at Xavier University of Louisiana, a colored university located at 7325 Palmetto St., New Orleans, La., phone: NU-8-6646.

He looks very anxious to do something to help fight the Communists in Cuba. He goes has attended most of the meetings in New Orleans since his arrival here a few months ago. (By the way, he and two other university professors were sitting together at the meeting Friday night). He

He arrived in Miami from Cuba in February 1962. He spent one or more days at Opa Locka. I don't know what date he arrived in Miami but he mentioned he left Opa Locka on a Friday or a Saturday.

I believe Dr. Quitart's wife is a sister or very close relative of Sara del Toro. Sara and her husband Amador Odio are in prison in Cuba now. Amador Odio was a Carlos Prío man some years ago and was also anti-Batista. Amador and Sara were both close to the Castro family in 1959.

and 1960. When one of Fidel's sisters got married, Sara gave her a party (I don't know how you call this type of party) before the wedding. The party took place at Sara's country home just outside Havana. Sometime in late 1960 or 1961 Sara and Anador were accused of conspiring against the government. Anador was sentenced to 30 years and Sara to 6 years. I believe Sara and Anador have nine children. They must all be in the U.S. by now.

Agustin's brother is [redacted] was a well known professor of Mathematics in [redacted] I know he taught at the [redacted] (the old rascal gave a rough time in math exams) for many years. I don't know if he ever taught at the [redacted] [redacted] is now teaching Mathematics at the [redacted]

Dr. Agustin Chitarr is now making about \$500.00 a month at Javier. I believe he speaks broken English.

Marcalino Melendreras - Left Cuba (Havana) 29 July via Mexico. He was in Mexico City 10 days and arrived in New Orleans Saturday, 10 August.

Prior to the communist government he worked in Productora de Superfosfatos (Superphosphates Factory) of Regla. When this factory was confiscated and included in the Consolidado de Fertilizantes (Fertilizer Consolidated) he performed the duties of Assistant to the Chief in the Technology Department. His services ended when he resigned a week before his trip. He informed me that the number of Russians has increased considerably and that when it was reported over short wave that a goodly part of them were returning to their country they were arriving in numbers larger than those who were leaving. Those which are seen in the streets of Havana are as many as the Cubans who also walk on them. All the buildings and houses of the district known as Habana del Este (East Havana) which was constructed and planned when the tunnel which crosses Havana Bay was built are inhabited by Russians and Czechs (the latter in lesser numbers than the Russians). This district was planned for well-to-do people and the houses ~~are~~ are of the best quality.

In Havana Province, the Russian camps are located in the surrounding areas of the towns known as Wajay and El Cano. Cubans are forbidden to transit through these towns (and) were removed from living there in favor of the Russian officials. In the surroundings are located machine guns and anti-aircraft guns in a large number.

It is well-known that the fishing terminal (near Havana) which was constructed in order to provide facilities to fishing vessels which operate on the North coast of Cuba has been converted into a base for Russian submarines. Mr Melendreras was in Santiago de Cuba and Holguin a few weeks before his trip but he did not hear anything said about the sub-

base said to have been constructed in Banes Bay, a city situated on the North coast of Oriente province.

While going through Las Villas Province at the entrance to the city of Santa Clara he was able to observe a large camp of Russian soldiers in tents. The airport in this city is controlled by Russians.

In Santiago de Cuba and Holguin many groups of Russians are seen but in a smaller number than in Havana. He believes that the number of Russians has increased instead of decreased since the October crisis.

In what regards food, that which is most abundant is rice and macaroni. Meat, when it is available, is given every two weeks, one pound per person. When he left Cuba a month and a half ago there were no eggs or chickens. In short, food is scarce and of poor quality throughout the island.

na son tantos como los Cubanos que transitan por ellas. Todos los
edificios y casas del reparto llamado "Habana del Este" que fue
construido y planeado cuando se construyó el Tunel que atraviesa la
Bahía de la Habana, están habitados por rusos y checos (éstos últi-
mos en menor número que los rusos). Este Reparto fue planeado para
gente de buena posición y las casas son de primera calidad.

En la Provincia de la Habana, los campamentos rusos están ubica-

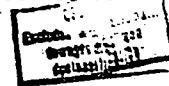



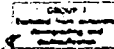

Following is some additional information as per our conversation during your last visit to New Orleans.

Cuban going back to Cuba.- Recently I heard through a third person that a Cuban is going back to Cuba. I have tried to find out details about this, but so far all I have learned is: it is a woman in her fifties whose husband is in Cuba. She has been living here with her daughter who is married to an American (Robert C. Baker, 538 Central Ave., Metairie, La.) She came to the U.S.A. to help her daughter and has been waiting for her husband and another daughter to join her here. Due to the fact that they haven't been able to come, she has decided to go back to be with them. She is anti-Castro. Her husband's last name is Vasquez and he was the director of the only Baptist school in the city of Holguin, Oriente province. (This is where they live) The school is intervened by the communist government. She has already received the cable from the Communist Cuban government stating she may return, but as far as I know, she hasn't left yet. This is all I have been able to find out.

#13- José Mata, in his forties.- 1501 Owens Blvd. (Apt. A) He was born in Santiago de Cuba, Oriente province. He was personnel manager in the First National Bank of Boston in Santiago de Cuba, presently employed by the Whitney Nat'l Bank here in New Orleans. Very honest person. He used to be enthusiastic but lately he has been very pessimistic. In conversations with him I have found that he cannot be of assistance.

#14- Carlos Mata, in his forties. Recently moved from 4421 Perlita St. to Duplessis St., but I don't know the number, and he will move again shortly. Brother of #13. Cuban lawyer, presently working with Standard Fruit Co. He is a very talented man. In Cuba he was the lawyer for the "Asociación de Comerciantes de Café". When he was living in Miami before coming to H.O. he was working with other cubans planning the new legislation to deal with coffee after Castro's overthrow. It is possible that he could be of assistance to you, but in conversations with him I haven't been able to find out whether he still maintains good connections in Cuba, which I think he must have.

#15- George Bonagosa, 35 yrs. old. Born in Havana. He worked for the "Compañía Cubana de Electricidad" and with his father in an import-export business. He is presently working for the grain company that he used to represent in Havana. He is a loud and boisterous character, but in the surface only. He is always willing to help with Crusada, and has done so in many occasions. He told me he did a lot of sabotaging against Castro before coming to the USA. I asked him once if he maintained connections with friends in the company and he came up with a list of "chivatos" (informers), so I really can't say whether or not he could be of assistance to you.

#16- Francisco Benares, in his sixties. Cuban architect. Working at Avondale Shipping Yard, as an architect. 4316 Perlita St. (Apt. B) Father in law of #8. He was a hard worker before his son in law was released from prison, for the Cuban cause, but ever since the prisoners were released he has retired to his family life.

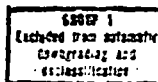

Dear Carl:

This sounds funny but in order to keep the subjects in separate letters I am starting this one. I want to get this one out to give you a chance to look it over before you come. During my visit up north we talked about contacting some professors. I told you there were two or three in this area. I did not have a chance to get close to any of them until last Friday. Here it goes:

Last Friday night (Jan. 25) my wife and I attended a meeting to commemorate the anniversary of the birth of Jose Marti. It was quite cold and not many people attended (the act was not well organized either). After the meeting one of the Cuban couples talked us into stopping at a bar before going home. It happened that Dr. Agustin Quitart (the university professor that looks most promising) had gone with them to the meeting. What a luck! I accepted with the condition that Dr. Quitart would come along too. He couldn't turn it down. I have been trying to get close to this man for some time and never had the opportunity before. I could not get as much information as I wanted but this is just a start.

Dr. Agustin Quitart was a well known professor of Physics in Havana. He was a professor at the Instituto de la Vibora (a very large public high school in Havana) for many years before becoming a professor at the University of Havana. Dr. Quitart is about 5' 5" and slightly on the heavy side. He has a little bit of grayish hair and a small mustache. He looks to be about 50 years old.

His home address is (from the phone book): 4009 Elba St., New Orleans, La. phone, 82 2-2815. I believe he lives there with his wife, daughter, son-in-law and grand-children. His son stays there some times. I believe he is going to school somewhere. His son-in-law is a Cuban lawyer called

Dr. Quitart is now teaching Physics at Xavier University of Louisiana, a colored university located at 7125 Palmetto St., New Orleans, La. phone: HU-8-6646.

He looks very anxious to do something to help fight the Communists in Cuba. He goes has attended most of the meetings in New Orleans since his arrival here a few months ago. (By the way, he and two other university professors were sitting together at the meeting Friday night). He

He arrived in Miami from Cuba in February 1962. He spent one or more days at Opa Locka. I don't know what date he arrived in Miami but he mentioned he left Opa Locka on a Friday or a Saturday.

I believe Dr. Quitart's wife is a sister or very close relative of Sara del Toro. Sara and her husband Anador Odio are in prison in Cuba now. Anador Odio was a Carlos Prío man some years ago and was also anti-Batista. Anador and Sara were both close to the Castro family in 1959.

and 1960. When one of Fidel's sisters got married, Sara gave her a party (I don't know how you call this type of party) before the wedding. The party took place at Sara's country home just outside Havana. Sometime in late 1960 or 1961 Sara and Anador were accused of conspiring against the government. Anador was sentenced to 30 years and Sara to 6 years. I believe Sara and Anador have nine children. They must all be in the U.S. by now.

Agustin's brother is [redacted] was a well known professor of Mathematics in [redacted]. I know he taught at the [redacted] (the old school gave a rough time in my exams) for many years. I don't know if he ever taught at the [redacted] [redacted] is now teaching Mathematics at the [redacted]

Dr. Agustin Giltart is now making about \$30.00 a month in Xavier, I believe he speaks broken English.
