1. Before he left to assume his duties as COS, Rome, Mr. William Harvey asked that we check into the present status of Operational Approvals on Subjects. A check of CI/OA revealed that one on Mr. Luce expired in 1958, and that there had recently been one active on Mr. Zellerbach for GCS use only.

2. It would be appreciated if OAs could be given to Subjects so that Mr. Harvey may be permitted to speak with them at any time in the future should they visit his area, or in the event that he seeks to see them whenever he is in the United States. Since it would be difficult to determine a time limit for keeping such OAs active, it would be appreciated if they could be given for an indeterminate period.




