1. LANGOSCH AND ANMUG 1, ONCE EACH ALONE AND ONCE TOGETHER SAW ⁰² [JUNAVE 1] MORNING 30 SEPTEMBER. ⁰² [JUNAVE 1] TOOK SAME POSITION AS PARA 2 REF A. DENIED KNOWING ANMUG DESPITE CASE OFFICER RELATIONSHIP, REFUSED DISCUSS ANYTHING ABOUT CUBAN INTEL, AND BEGGED FOR RELEASE AND EXILE TO START LIFE ANEW.

2. OBTAINING TRUTH FROM ⁰² [JUNAVE 1] WILL BE TIME CONSUMING. HE FULLY AWARE PROOFS AGAINST HIM BUT PROBABLY HOPES POLITICAL PRESSURE WILL FORCE RELEASE AND PROBABLY FEARS ADMISSION OF HIS COMPLICITY WILL NOT HELP HIM. SALV GOVT MUST CONVINCHE HIM HE WRONG ON BOTH COUNTS. HE OF DUBIOUS VALUE INsofar AS CONTRIBUTING NEW INFO ABOUT PAST ACTIVITIES OF CUBAN INTEL OR PCES BUT OF CONSIDERABLE INTEREST AS AGENT IF HE CAN BE TARGETTED AGAINST CUBAN INTEL OR PCES. IF RELEASED WOULD BE DEFINITE OBSTACLE TO FURTHER OPS AGAINST ANMUG TARGETS. IF HE SHOULD BE DOWLED, HIS IMPRISONMENT WOULD COVER RECRUITMENT AND WOULD TEND TO ENHANCE HIS VALUE. PROBABLY WOULD BE MOST USEFUL OUTSIDE SALV INCLUDING MEXI AND CUBA.

3. AS MATTERS STAND MOST IMPORTANT TO PROTECT HUMAN EQUITY IN
 02 [JUNAVE 2] WHO OF GREAT PROMISE. THIS GR COULD BE AFFECTED ADVERSELY
 BY SPREAD OF NEWS ABOUT ANNUS EFFORTS ON BEHALF OF KUDARKA TO EFFECT
