FOLLOWING FROM CORRIGAN RE REACTION LANGOSCH BRIEFING

1. WITH EXCEPTION PANAMA GROUP [THE MINISTERS OR INTEL CHIEF] EACH COUNTRY:

- A. APPEARED DISPLAY AWAKENED INTEREST IN CASTRO SUBVERSION IN CENTRAL AMERICA.
 - B. EXPRESSED INTEREST RECEIVING MORE DATA ON AGENTS AND TRAVEL OF NATIONALS TO CUBA.
 - C. INDICATED HOPE IN RECEIVING SOME GUIDANCE ON HOW MOVE AGAINST THREAT (THIS SPECIALLY TRUE OF [unclear] [unclear] SECRANO).
 - D. LOOKED TOWARD HOPE TALKS WITH COYCKE REPS UPON RETURN HOME.
2. RE PANAMA DELEGATION NOTED [unclear] [unclear] PERIODICALLY DURING TALK AND UPON COMPLETION COL. [unclear] ASKED CORRIGAN IF WE HAD MORE DETAILED INFO THAN THAT MENTIONED IN RND AND TALK; HE TOLD THAT WOULD BE MATTER FOR DISCUSSION UPON HIS RETURN HOME. PANAMA DELEGATES GIVE OUTWARD APPEARANCE MERELY GOING THRU MOTION OF ATTENDANCE AND TO

DATE HAVE OFFERED OR ADDED NOTHING POSITIVE TO MEETING. SUCCEEDED
 HAVING NEXT [SECURITY CHIEFS] MEETING MOVED FROM PANAMA TO GUAT BY
 INITIALLY CLAIMING RAINY SEASON PRECLUDED PANAMA AS SITE. LATER SAID
