1. DO NOT BELIEVE THAT ANY FURTHER DIRECT ACTION AGAINST RUCIO GONZALEZ (24. [SUCH AS "ACCIDENT" IN MEXICO AS SUGGESTED BY ERTINHOID ONE REF B]) IS EITHER FEASIBLE OR DESIRABLE. SINCE HIS STORY OF DETENTION, INTERROGATION, AND RECRUITMENT APPROACH ALREADY SURFACED IN MANAGUA PRESS, ANY FURTHER REPORTS OUR PART EITHER TO INTERFERE WITH HIS MOVEMENTS OR TO ATTEMPT COUNTER PUBLICITY WOULD HEREBY KEEP HIS CASE IN PUBLIC EYE AND POSSIBLY LEAD CREDENCE TO HIS FANTASTIC (ALBERT TRUE) STORY AS PRINTED BY LA NOTICIA ON 8 OCTOBER IN MANA. SINCE HE WAS NOT ARRESTED OVERLY WITH OTHER NICS RECENTLY (NONE OF WHOM WERE INTERROGATED OR PITCHED BY "YANGUI AND CURAI") AND MORROVER WAS FREED UNCONDITIONALLY, EVEN HIS FRIENDS MAY NOT FULLY BELIEVE DETAILS HIS ACCOUNT OF HOW HE WAS PITCHED BY [NIC SECURITY SERVICE.]

2. RECOMMEND (MANA STATION) 16-22 ENDEAVOR CONVINCEN (LIAISON) 24 TO DENY GRANTING (OR AT LEAST DELAY AS LONG AS POSSIBLE) GONZALEZ REQUEST FOR SAFE CONDUCT TO MEXI.
