VARIOUS MEMBERS OF THE OLD CONSTITUTIONAL ARMY, THE REBEL ARMY, AND THE NATIONAL REVOLUTIONARY MILITIA WILL JOIN IN THE UPRISING. UNITED STATES PRESS SERVICES WILL BE ASKED TO GIVE FULL PUBLICITY TO THE UPRISING AS SOON AS IT STARTS.
- 2. IT IS POSSIBLE THAT FIDEL CASTRO HAS HAD TO BRING IN FOREIGN.
