1. According to SGAA-33428 (29 Aug. 58) no one in Kathimershi had ever heard of DINITRAKOPOULOS before 1948. He reportedly was introduced to Kostan ZAFEFROPOULOS (of Eathimerini) by Leon MAKKAS. According to EKAW-7039 (15 Dec 1966), THUFFORM/20 stated that dating way back to the 1950's DINITRAKOPOULOS was considered an American sgent and that he had good access to Greek military information via Leon MAKKAS who at that time was "Chief of Staff of the Greek Navy" and through whose offices he had mangged to get good access to the Greek Pentagon. The following are pertinent Headquarters traces on MAKKAS and ZAFEIROPOULOS:

## A. MAKKAS, Leon (201-232863)

Born 1892, in Athens, Greece, the son of Dimitrios; studied law at the Universities of Athens and Paris; 1914-22 - Journalist in Paris; 1922-28 - Director of the Press Bureau of the Greek Embassy in Paris; entered politics in the August 1928 elections under the Liberal Party banner and elected Deputy for Athens; Under-Secretary of the Navy (Plastiras cabinet) 15 April-18 Aug 1950, and in 1952 a member of the Greek delegation to the UN General Assembly, fifth session, New York. He remained in Greek politics upuuntil at least 1965.

A report from the 8th Service Command, ASF, Dallas, Texas, dated 17 Apr 45, contained the information that when the Germans left Cophalonia, the ELAS forces took over police, customs, and all administrative duties of the island. The Greek Government of Athens Sent a commission headed by fau MARAS to Cephalonia and Corfu to set up an administration, which he did but "did not seem to interfere or have any difficulty with the ELAS forces." The MARAS mentioned may or may not be identical with Leon MARKAS.

MAKKAS throughout his career has espoused the idea of improving Greek-Soviet and Greek-Bloc (particularly Eulgarian and Yugoslav) relations. Eleftheria carried an article on 22 June 1956, in which MAKKAS strongly urged, among other things, the betterment of relations with the Soviet Union and referred ironically to the Government's "service attitude" towards the Western allies in this connection.

In mid-May 1957 (SGA-5371, 28 May 57), a Provisional Committee Against Thermo-nuclear Tests and Atomic Warfare was formed in Athens under Leon MAKKAS as president. Two former EDA officials, Traklis PAPACHRISTOU and his wife Eurydic SPYROMILIOU (the latter with a record of pro-Communist activities up to the end of 1955), played prominent roles in this organization; at least five of the sixty personalities who signed the initial appeal of the MAKKAS organization were Communists or pro-Communists; at least 15 other persons who signed the appeal had a record of activity in one or more of the Greek Communist front organizations. MAKKAY has been a member of numerous organizations such as the WPC Congress, Stockholm, 16-23 July 1958; the Sponsoring Committee, Congress for Disarmament and International Cooperation, Stockholm, July 1958 (in which organization he was closely associated with Stamatics MERKOURIS); the Governing Council of the Greek Peace Committee, January 1959, and others.

MARKAS went to Bucharcat in September 1959 at the invitution of "RPR National Committee for the Defense of

the Poors". He attended the third East-Dest Round Table Conference at London in February 1960, which was leftwing and Communist in tone.

In January 1958, MARKAS proposed to Eumanian Ambasicador Ion DRINCEANU that a Balkan conference of personalities representing organizations along Afro-Agian Conference prototype be formed. HARKAS suggested Belgrade as a conference site but DRINCEANU disagreed on the site location and suggested Bucharest. MARKAS visited Belgrade to-discuss the above situation with Micha PAVITCUEVITCH.

ATHE 0469, 21 Jan 58, reported that a usually reliable source close to GOG circles stated that "it was evident that Leon MAKKAS had gone constantly over to the Commic side and was now participating in the publication of the Commic front magazine <u>Public Cpinion</u>" and that Theodore VCKAS, the former director, was a long-time Communist. <u>Public Opinion</u> had run a poll on the misuile site question, "coming up with the absurd conclusion that 70 per cent of the Greeks were opposed to the missiles."

CS 3/344,265, 14 Feb 58, Subject, "Leftist Plans for Future Action in Grocce," reported that EDA Deputy 11 na ILIOU met with former Minister of Commerce Loon MAKKAS on 30 December (1957) and discussed the leftist plans for future action in Greece; MAKKAS agreed fully that EDA should follow in the future a polley of coexistence with other parties; independence in foreign policy; resistance to NATO atomic and missile bases for Greece; democratic and Social justice, etc. MAKKAS also promised full cooperation in any new popular front.

In December 1963, MARKAS reportedly was appointed Greek Ambansador to Belgrade. After his appointment was mentioned in the press, THODIUM reported that MARKAS had called the Soviets about his appointment. THPLANK told Chief of Station, Athens (CUSICK) that he thought the calls were very suspicious and had asked Minister of Fereign Affairs Sofeklis VENIZELOS net to appoint MARKAS to Belgrade. VENIZELOS reportedly told THPLANK that although "MARKAS was a stupid and ridiculous man, he was hardly a Soviet dpy." VENIZELOS reportedly wished to improve relations between Greece and Yugoslavia with the appointment of MARKAS. (Headquarters files do not reflect that MARKAS! appointment ever became effective.)

In June 1965, it was reported (PARI SS14, 25 June 65) that "left leaning" MAKKAS had replaced Spire PRECASCOSMETATOS (Counselor of the Greek Embassy, Paris, for Press Affairs for more than twenty years). MARKAS reportedly protested his predecessor's follore to establish contact with the Communist paper L'Humanite.

In March 1965, it was reported that MAXMAS, Greek Permanent Representative to the Council of Europe, had been sent on a mission in Paris according to George PAPANDAREOU's instructions estensibly to represent Greece in the Council of Europe but to actually obtain information regarding EARAMANLIS' movements, plans, views, etc. These reports reportedly had been received regularly by PAPANDAREOU through secret and non-diplomatic channels

It should be noted that MAKKAS has been a close personal friend of George PAPANDREOU since before the occupation years of Greece.

B. ZAFEIGOPOULOS, Konstantine (201-836761)

Dorn 1908, Kalavryta, Achula, Greeco Don of George and Earla Journalist

PGA-4728, (1 Mar 50) which discusses the "Reorganization of Soviet Intelligence Network in Greece" states that information on Greece has from the Soviet point of view in general been accurate because many journalists have actively collaborated with the Soviet service. Before the outlawing of the KKE, a list of trusted journalists were selected for information purposes by the Sovietu--once more on the orders of Leonid VELICHANSKY (former TASS representative in Athens). The name of Constantine ZAFIROPOULOS was included in the list of journalists in whom the Soviets were particularly intorested.

EGA-2300, (2 Aug 54) which contained information concerning lists of journalists allegedly prepared for the Soviet Intelligence Service lists ZAFEINOPOULOS" many in a section designated "Communist and EAM Journalists in Athens" and described him as follows: "Ne is our man but is not organized. He is a journalist for <u>Kathimerini</u> and is useful to us in that post. He is a creation (sic - protege?) of Costas VIDALIS. Years ago he sympathized with Trotskyism. He is a valuable prospect but an opportunist. Nevertheless, he is exceptionally useful to us."

ZAFEIROPOULOS has been a journalist and Director of Political Affairs for Esthimerini since the early 1950's, as well as a writer for Radio Athaus for several years in the 1950's. According to EKA-2444, (21 Aug 62), ZAFEIROPOULOS was editor of Kathimerini.

2. In a WOBONE report concerning DIMITRAKOPOULOS' contacts in the United States during his June-July 1953 visit, it is noted DIMITRAKOPOULOS was in telephonic contact with Dimitrios LAMPROS (then Counselor of the Greek Embassy) at his Washington, D.C. (Chevy Chase, Ed.) home address.

## LANBROS, Dimitrics (201-835826)

Born 7 March 1903, Alexandría, Egypt Bon of Micholas

Former private scoretary to Prime Minister Eleftherios VENIZELOS; member of Greek Foreign Ministry since 1920/ 1949-1952 Deputy delegate, UN General Assembly, fifth sconion, New York, According to an LNGOLD biographic summary dated 24 September 1949, LAMBROS is reported by some Greeks to be an actual of potential follow traveler. The writer of the report, however, states that it is difficult to assess the validity of this charge although it had been made by persons who were not normally given to making extremat parties judgments. He states further that the bauls for this charge may be LAMBROS' personal

friendship with several persons of known leftist economic views.

According to EKAA-3006 (Attachment C), Rade (ROST, Yugoslav Commercial Attache in 1959-60, was in frequent contact with Dimitrion LAMOROS, described as "Commercial Representative." This document also stated that TROST was cultivating neveral Greek NEA types. (According to EKA-788, 23 Oct 59, and EKAA-4996 [Att. C] DIMITRA-KOVOLOS and TROST had frequent contacts).

3. According to EKAA-14891 (1 Oct 66), Senator Vance HARTKE, accompanied by his close friends, Mr. and Mrs. Eliot JANLWAY, visited Greece in September 1966, and were wised and dined by DIMITRAKOPOULOS and introduced to many high-level Greek and other foreign government officials as his "old and dear intends."

The Congressional Record, dated 22 March 1968, contains two fices concerning interviews by DINITHAKOPOULOS with HARTKE and JAMEWAY, respectively. (Accopy is attached for your information.)

## JANEWAY, Ellot (201-833459)

The folloping background summary, dated August 1952, was furnished by LNERGO;

Ellot JANEWAY was been in NewyYork State on January 1, 1913. His father, Never JACOLSTEIN, was been in Eussia but the nationality of his mother is unknown. Co November 9, 1931, while attending Cornell University, JAMEWAY married Carol MINDSFOOS, an American citizes. After graduating from Cornell in 1932, JANEWAY and his wife traveled to England for the purpose of pursuing their studies at the London School of Economics.

According to a reliable foreign source, JANEWAY and his wife left the Unifed Kingdom on August 30, 1933, and traveled to the Soviet Union. This trip was reportedly Influenced by Serget DINAMOV of the Russian Union of Revolutionary Writers. Prior to making this trip, JANEWAY indicated that he was not a member of the Commuaist Party but intended to become one upon his return. to the United States. During the period of time JANEDAY sas in the Soviet Unico, little is known of his activities, according to the roliable foreign source, other than the fact that he was coployed as a typist and reporter for the Moscow "Daily News," While in the Soviet Union, JANEWAY and his wife neparated. She obtained a position as Moscow conrespondent for the Bearst newspapers and he returned to the United Bingdom for the avowed purpose of continuing his studies at the London "School of Economics, November 24, 1933. JANEWAY did not resume his studies in London, however, but left for Austria in January 1934 shere he remained for two weeks. He allegedly returned to the United Kingdom accompanied by Berta HOLLERING, an Austrian Communist.

According to the reliable foreign source, JANEWAY joined the Communiat Party of Great Britain in November 1933 and wait a member of the Southeastern Sub-District. He is alleged to have earned a bad reputation with British Communists and on Yebruary 21, 1934, the London "Laily Worker" announced the expulsion from the Communist Party of J. JANEWAY on the grounds of political unreliability. This individual is believed by the reliable foreign source.

to be identical with Eliot JANEWAY. JANEWAY left the United Kingdom for the United States on February 23, 4934, and upon reaching this country reportedly informed the American Communist Farty that he had been disciplined by the Communist Farty of Great Britain.

Elfot JANEWAY was at one time associated with the International Statistical Europa, 70 Fifth Avenue, New York City, and with Pendleton, Dudley and Associates, 270 Brondway, New York City. He has at various times contributed articles to the following publications: "The Nation," "Asia" magazine, the "New York Times" Sunday Magazine Section, "Fortune! magazine, "Life" magazine, "Deutoches Volksceho," and the Federated Frens. In 1941 he was Associate Editor of Time, Incorporated. As of April 1952, JANEWAY was identified as a consulting economist and business trends consultant for "Newsweek" magazine.

A news item appearing in the June 10, 1938, issue of the "New York Times" indicated that Eliot JANEWAY was a cospeaker with Dr. Harry W. Laidler, State Chairman of the Socialist Party of the State of New York, in the opening session of the annual conference of the League for Industrial Democracy. This conference was held at the Unity House, the Summer camp of the International Ladies Garment Workers Union at Forest Park, Pennsylvania, on June 9, 1938.

(NOTE: Ecadquarters files contain the following information concerning an individual who is possible identical with Berta EGLIERING, mentioned in above LIERGO summary:

A reliable source knowledgeable of Cemintern acti-Witles in Europe during the 1930's advised that one Earbara TARNAY, believed to be an alias used by one Gertha BURGESS, was known to Comintern officials in England and Austria as Barbara ARCHER; Bertha TARNAY and Bertha HOLLERING. TARNAY was recommended by Comintern officials in London in 1934-1935 for courier duties. She had previously worked for the Comintern in Austria, using the names Bertha TARNAY and Bertha HOLLERING. Source is not knowledgeable of TARNAY's present connections or activities.

An LNGOLD Visa check dated 31 December 1964, contained the following biographic information on Berta T, BURGESS:

Born 28 July 1801, Vienna, Austria; marital status-Beparated; citizennhip-British; address-41 Fellows Road, London: NW 3; employment-retired.)

An LNERGO report (dated 11 Oct 54) contains the information that the Yugeslav Dalegation in New York City was the recipient of correspondence dated 20 July 1054 from Eliot JANEWAY, 270 Park Avenue, New York City. Another LNERGO report contains a reference to one Margaret JANEWAY who made out a check, dated 11 December 1953, to Evetetak Kentu HANDURIC aka Mcsmara HANDUKIC (201-3060), who was known to be in frequent contact with Yugeslav Government officials in New York City. (See Summary on Jack WASSERMAN below for further mention of MANDURIC.) Headquarters traces on Margaret JANEWAY were megative and ENERGO

had no additional information which might the in Margaret JANEWAY with Milot and Carol JANEWAY.

In another LNERGO report (dated 24 Nov 54) concerning Louis FISCHER, aka FISHLR (201-5286), who, according to LNERGO, has been considered by many to have been a Boylet agent for many years, Carol JANENAY's name appears in a section cutitled "Activities and Associates (of PISCHER) after the German-Soylet, Pact, August 1939," as follows:

An LNERGO source of unknown relazbility furnished information in 1942 which indicated that MISCHER was in contact with Carol JANEWAY, 124 East 19th Street, New York City, in December 1941.

Another LNERGO source of Lnknown rollability advised on 7 October 1952 that Carol JANEWAY hold memberchlp in the Communist Political Association in 1954, and was a member of the Sacco-Venzetti Club.

The above informant stated that Carol JANEWAY attended schools in Soviet Russin during the 1930's when she wisited that country (although source did not believe the schools were directly connected with the Communist Party), and that she had Communist literature in her apartment.

According to the above LNERGO report; FISCHER recalled having met Carol JANEWAY and her mother in Russia during the 1930's. He said she was an anateur painter or artist.

4. WASSERUAN, Jack (201-240834)

902 Warner Building, Washington, D. C.

Lawyer for Robert BRIMBERG Company (DIMITRAKOPOULOS' alleged current employer), who represented DIMITRAKOPOULOS in filling his 6th Proference Petition to IENS.

LNERGO reports describe WASSERMAN as a controvoralel type, known as a successful, enopole ottorney, who has been legal counsel for many IANS cases and internal security cases (which pertain mainly to persons connected with pubversive groups, Soviet cover organizations and persons with Soviet affiliations.)

An LNERGO report dated 20 August 1954, indicates that WASSERSIAN had made out a check in the amount of \$125.00 to one Syctovar MANDUKIC (201-3060). MANDUKIC, of Yugoslav extraction, was negotiating with the Yugoslav Covernment regarding the construction of a rayon mill in Yugoslavia, and was in frequent contact with Made TROST, Commercial Attache at the Yugoslav Consulate in Now York City in 1954.

Svetovar MANDUKIC and his wife Kousara MANDUKIC (neo MILQIKOVIC) have been varioually reported primarily by sources in Thirkey as collaborators of the German during World FAN II, ingents of OEMA (the Yugoniav Intelligence and Security Service) and the successor intelligence organization UDD, and possible Sovietingents or informants. MANDUKIC's file, hewever, indicates that the information may have originated from two Yugoniav sources which were considered unreliable and prejudiced. An LNFRGO report, however, dated 29 July 1950, stated that Konsara MANDUKIC was reportedly in contact with an alleged Yugoniav intelligence agent in New York City, and described her an a person of loose consider Another LNERGO mource utated that mhe would be the type of individual who would carry out an intelligence ansignment for a Yugoniavidual

1. In attempting to clarify the many discrepancies, inconsistent reports, and allegations, in Subject's background a thorough review of his file has caused us to look more closely at some of his part close associates. Additionally, some new names have some up. The following is a resume of recently run traces on a few of his old contacts as well as the new ones. It is interesting to note that some of these contacts tend to the Subject in oven more closely with the Yugoslav and/or Soviet I.S. We would appreciate current Station traces on all contacts mentioned below.

## 2. Early Mistory and Old Contacts

A. PGAA-3593, 6 February 1951 (a copy of which is in Station files), might be considered the basic document on which the stories are based of Subject's "heroic escapades" during the occupation of Greece by the Germans. Additionally, you will recall Subject's many later verstend of his heroism and of the wounds received in his leg (i.e. German bullets, Communist bullets, Russian bullets). The following are traces concerning several individuals mentioned in IGAA-3593 (6 Feb 5F) who were involved in one way or another in the ceremony held at the Coeff Hotel, Alfissia, in May 1950, at which Subject reportedly was awarded the "Highest Decoration of the Military Cross of the Apostle Evangelist Mark," for his activity in the Greek resistance movement during and after the German occupation.

1) CHMFSTOFOROS 11, (201-534549) Greek Orthodox Patriarch of Alexandria (from at least the carly 1940's until late 1950's).

There are numerous old reports (mainly originating-with State Department) which describe CHRISTOFORUS as having been noted for his pro-Communiat and pro-Soriet tendencies. The these throughout many of these reports is his cloneness to the Muscow-dominated Russian church in Alexandria (Patriarch Alexis), his numerous trips to Moscow; his frequent contact with Soviets in Alexandria, his alleged aid to Greek Communists in heypt, and the fact that he surrounded himself with (Greek) Communists; such as Emmanuel (Nadoly) GAEFTOS who is described as CHRISTOPOROS' "confidential agent." After complaints made to GURISTOFONDS by the British Consul General In Alexandria (1948/49) about the employment of GNEFTOS, CHRISTOFCEOS promised that GNEFTOS seculd be dismissed; it was later proved that GHEFTCS remained in the employ of the Patriarch. CHRISTOFOROS reportedly was an active supporter of ENOSIS.

CHRISTOFOROS reportedly arrived in Athens on 24 February 1950 from Alexandria to confer with the Archbiahop of Athens on collectinstical matters. While there, he was also given bonors by military units. (At may have been on this visit that plans were made for him to officiate at the ceremony for DIMITRANOFOULOS.) CHRISTOFOROS returned to Alexandria on 11 March 1950.

2) GNEFTOS, Emmunuel (Manoly)

Reportedly (DOI March 1950), an alleged Communist who is confidential spent for CHRISTOFOROS, Greek Orthodox Fatriarch of Alexandria, and head of the latter's Embor Employment Office, was sent to Athens (January 1950) to discuss ENGSIS with General ZERVOS, estreme rightist tender. ## Journalist and Lawyer

According to SGA-2341, 12 July 1954 (Subject: Communist sho Leftist Journalists), Subject was Under Alpister of the Fress under the Methans regime; during the occupation was an EAM addirer and supporter; after the Varkiza Agreement, was political reporter for Eleftheri Linda for some time and wrote various articles in the Socialist newspaper Eleitheros. On 2 June 1947, he was sent to Prague with three other nationalist journalists to represent Greece at the congress of journalists. In 1950 he was a condidate for Farliament of the Liberal Farty and in 1951-1952 of LEEX (National Reognessive Union of the Center). The newspaper Elitaiki Imera of 14 August 1952 published a performation afgued by Subject regarding the roleaso of Empinuel GLEZOS from prison, which was sent to the Price Minister, the Minister of Justice, and the Freudent of the Review Court. The newspaper Allagi on 25 September 1952 published a letter from Subject to the PEOPER (Faumblichic Union of Families of Political Exiles) about seading parcelsto prisoners. Avai on 18 December 1952 published a letter from the FEOREF to Subject in answer to the letter he sent about parcels for prisoners thanking him for it. Avgi on 7 December 1952 published geoplings from the Provisional Committee for Peace Followers in Greeco to the Peace Congress in Vienna, signed by Subject.

In June 1935, BREDIMAS spoke at the Feace Congress in Holainkly Finland; 1957 - visited satellite countries and wrote lengthy series of pro-Communist articles which appeared in Athinaiki; appeared many times an defense witness for Communists on trial; frequent caller at the Soviet Embasis; elected to Parliament in May 1958 elections, on the EDA slate; reportedly loyal to EDA.

ATHE 6865 (23 Jan 57) reported that action was being taken by the Greek Government to deprive BREDIMAS of parliamentary immunity and to try him for contacts with TRIANTAPYLLOU of the EES. BREDIMAS confessed to the contacts but claimed he was not aware of the identity of TRIANTAFYLLOU.

EKA-137 (20 May 59) and EKA-515 (13 Aug 59) reported Subject as a member of the Atheus Committee of the fellow-travelling Democratic Union (DE) Party, Subject reportedly knows Second Secretary of the Soviet Embanny, Athens, Ivan BAYCROV (circa 1959), and Soviet Ambassador Mikhail Grigoryevich SERGEYEV; is a prominent fellow-traveler who bas-bad direct

5) DE DA MOTTE, John (201-68028).

French citizen, born 1921 in Marseilles, France; 1943 - warried a Greek woman (name unknown).

According to SGAA-16519 (13 July 55) (Source: GALATEA); DE LA LOTTE in a leftlist French journalist and former representative (1954) in Athens of France-Solr and a contributor to Ethnikos Kyryx, Eleftherin, and Athinniki; reportedly an agent of the French Intelligence Service while Press Secretary at the Frence Eubnusy in Athens (circa 1947-50) but work disminsed in 1050 following the discovery that he was fabilesting information and carrying out pro-Combuilat missions and because of his Communist convictions. It was alleged that DE LA MOTTE began working for the Soviets about 1950, and was still an active egent of the Soviets in 1955. He was reportedly hired as an agent of the Soviet Intelligence bervice and was in close contact with TAGS representatives in Athens, Leonid VELICHANSKY (201-63927) (in Athens in late 1940's and carry 1950'c) and Mikolal GUSEV (201-20808) (in Athena circs 1950-1952) and with notorious Greek Communists abroad. Additional reports allego that he was an agent of the Yugoslav I.S. and in contact with Spyridon THEODORCU (201-58345) Bathfrerin1 and Athinaiki correspondent in Paris and a can with a long Communist record who was i linison contact of the KKE from 1947 to 1949. THEODOROU was condenned to death in absentia by a Greek court in 1952 for participation in a KKE: emptopage network. THEODOROU was in blose contact with the Yugoslav Embacsy in Paris.

DE LA MOTTE reportedly is a close friend of Banil MATHIOPOULOS (201-304904), Greek journalist new residing in Boan, Germany, and was responsible for bringing HATHIOPOULOS in contact with TASS representatives VELICHANSKY and GUSEV in Vienna. The report states that it appears that HATHIOPOULOS had contact with the KKE upon his departure from Greece because in "Germany he casily came in contact with party with the ISB active in hest Germany with the Pollitbura of Prague."

DE LA MONTE was a close associate of Roger MILLIEX (201-224149) (currently French Cultural Attache in Micosia) when both were assigned to the French Embausy in Athens in the late 1940's, where both were reportedly contacts of VELICHANSKY. Roger and hig wife Tatiana GRITSI-MILLIEX reportedly are both Communists with many high-level contacts in the KKE. Tatiana reportedly was a Soviet agent before her marriage to Roger and served as a recrutter of Communist fighters during the Greek Civil War. (As has been noted in previous correspondence, Tatiana has been reported to have an am yet undetermined family relationship with VELICHANSKY.)

During the fall of 1954 (SGAA-16519, 13 Jul 55), it was noted that a vehicle belonging to Nikolay 2000000 (reportedly a senior Soviet 1.S. officer in

Also during meetings in asshington, p.C., in sig-1951, between a wobled representative and iddivated by DOULCS (during which the latter offered his services to MCEIRM) (see Director 420299, 10 Get 67), DIMITRAKOPOULOS statethat BARTON was his local (Athens) contact for communications. The WODISH report described BARTON as an Winformation Officer with USIE."

It should be noted that BARTON was assigned to Athens during the name period that both Konntanting ROUSSEN (201-257580) and Celia NAS (201-22534) (who inter married DIMITRAEOFCULOS) were employees of USIE (USIS) and both the latter were believed to have been used by DIMITRAEOFCULOS as sources of information. It is possible that DIMITRAEOFCULOS exploited his relationship with BARTON is a similar fashion.

The following blographycal information on MAMTGA was provided by USIS:

BALTCH was born 18 August 1915, in Terente, Canada; during World War II, we worked with 685 (British and French); circe 1944-7 worked for ICA and ECA (new AID); late 1940's, Attrche Information Officer (FSS-4), Tehran and Istanbul; 1950-52, USIS, Athens; position terminated 27 February 2053 and BARTON vention LWGP; June 1962-freefance viter residing at Shadyshide Avenue, Port Washington, New York. A reference of BARTON's in 1962 was one Henry VOLKENING (no Headquarters traces); a literary agent of questionable loyalty. A Civil Service investigation on Subject in 1948, and updated in 1954, revealed that it was rumored that BARTON was drinking: heavily.

C. According to SGAA-33428 (29 Aug 58) no one in Kethimerini had ever heard of DIMITRAKOPOBLOS before 1948. He reportedly was introduced to Kostas ZAFKIROPOBLOS (of Kathimerini) by Leon MARKAS. According to EKAD-7039 (15-Dec 1966), [HUNIFORM/20 stated that dating way back to the 1950's DIMITRAKOPOBLOS was-considered an American agent and that he had good access to Greek military CONTRACTION OF

## 1) BAKKAG, Leon (201-232863)

Born 1892, in Athens, Greece, the son of Disttriest studied inwat the Universities of Athens and Paris; 1014-22-journalist in Paris; 1932-23-Director of the Press Borcau of the Greek Embrasy for Paris; entered polities in the August 1025 clocitons under the Liberal Pariy basher and elected Reputy for Athens; Under-Secretary of the Navy (Finstfras cabinet) 15 April-18 Aug 1956, and in 1952 a member of the Greek collection to the UN General Amembij, flith cession, See York, He remained in Speck politics up until at least 2005.

A report from the oth Service Command, ASF, Iwliam, Texat, arted 17 Apr 45, contained the intermation that when the Command left Cephalonia, the ELAS forces took over police, customs, and all administrative defice of the boland. The Greek Government of Athens sent a commission header by intermation, which he did but "did not seem to intericute or have any difficulty with the ELAS forces." The MAZAS mentioned may or may not be identicat with Leon MAKAS.

HARRAS throughout his career has enjoyed the idea of improving Greek-Soviet and Greek-Bloc (particularly Bulgarian and Yugoslav) relations. Eleftheria carried an article on 22 June 1956, in which EARRAS strongly used, among other things, the betterment of relations with the Soviet Union and referred invalually to the Government's "service attitude" towards the destern allies in this consection.

In ield-May 1957 (SGA-5371, 28 May 57); a Frovisional Committee suginat Thermo-nuclear Tests and Atomic Machare was formed in athens under Leon MAKKAn as president. Two ferser ECA officials, Iraklis PAPACHAISTOU and his wife Eurydic SPYROMILICU (the latter with a record of pro-Communist activities up to the end of 1955), played prominent roles in this organization; at least five of the sixty personalities who signed the initial appeal of the MAERAS organization were Communists or pro-Communists; at least 15 other persons who signed the appeal had a record of activity in one or more of the Greek Communist front organizations. MAKKAS has been a member of numerous organizations such as the VPC Congress, Stockholm, 16-23 July 1958; the Sponsoring Committee, Congress for Disarmament and International Cooperation, Stockholm, July 1958 (in which organization he was closely associated with Stamatios MEHKOURIS); the Governing Council of the Greek Peace Committee, January 1959, and others.

MAKKAS went-to-Bucharent in September 1959 at the invitation of "UPR National Committee for the CONTINUATION OF

ATHE 6469, 21 Jan 58, reported that a usually reliable source close to 600 circles stated that "it was evident that Leon MARKAS had gone cospletely over to the Comple side and van now participating in the publication of the Completer version and azime "ublic spinion" and that Theodere VCKAS, the former director, was a long-time Communist. Public opinion had run a pull on the missile site question, "cosfug up with the shourd conclusion that 70 per cent of the Greeks were opposed to the missiles."

CS 3/344,205, 14 Feb 55, Subject, "Leithet Flans for Future Action in Greece, reported that Ein beputy flans 14.100 met with former Minister of Conserve Leon MAKRAS on 30 becember (1957) and discussed the lettist plans for future action in Greece; MAKRAS agreed fully that EDA should follow in the future a policy of co-existence with other parties; independence in foreign policy; reatstance to MATO atomic and ministre bases for Greece; democratic and social justice, etc. MAKRAS also promised full cooperation future popular front.

In December 1963, MARKAS reportedly was appointed. Greek Ambassador to Belgrade. MAKKAS reportedly protested his predecessor's failure to establish contact with the Communist paper L'Humanite.

In March 1965, it was reported that MARKAS, Greek Permanent Representative to the Council of Europe, had been sent on a minuton in Parls according to George PAPANDREOU's instructions catenaibly to represent Greeco in the Council of Europe but to actually obtain Information-regarding KARAMANLIS' movements, plans, views., etc. These reports reportedly had been ONTINUATION OF SECRET

FGA-4728, (1 Mar 50) which discusses the "Neorganization of Soviet Intelligence Network in Greece" states that intornation on Greece has from the Soviet point of view in general been nocurate because many journalists have actively collaborated with the Soviet service. Defore the outlawing of the KKL, a list of trusted journalists were selected for information purposes by the Soviets--once more on the Grders of Legald VELICHASSAY (former TASS representative in Athens). The name of Constanting TAFIRGECUCCS was included in the list of journalists is whom the Soviets were particularly interested.

5GA-2390; (2 Aug 56) which contained information concerning lists of journalists allegedly prepared for the Soviet Intelligence Service lists ZAFEIROPCULCS' name in a section designated "Communist and EAM Journalists in Athens" and described him as follows. "He is our can but is not organized. He is a journalist for Kathimerini and is useful to us in that post. He is a creation (sie - protege?) of Costas VIDALIS. Years ago he sympathized with Trotskyism. He is a valuable prospect but an opportunist. Nevertheless, he is exceptionally useful to us."

ZAVEIROFOULOS has been a journalist and Director of Folitical Affairs for Kathimerini since the early 1930's, as well as a writer for Radio Athens for Several Years in the 1950's. According to EKA-2444, (21 Aug 62), ZAFEIROFOULOS WAS editor of Eleni VLACHOU's Kathimerini CONTINUATION OF

## 3) VLACHOU, LICH1 (201-300212)

Cours and Publisher of Kethimerint from 1955 (when she inherited it from her lather, George VLACHOD) until April 1967, when she closed down the newspaper after the military coup.

Among Mrs. VLACHOU's Kathirerini staff were Konstantine ZAFEIRCPONLOS; Evangelos ANDROULIDAXIS (see summaries); Konstantine ROUSSEN (201-251580) with whom she reportedly had a very close association (see NKAN-33, 20 Oct 67 for summary of ROUSSEN/DIMI-TRANGPOULOS relationship--it has been noted that ROUSSEN and alleged to have passed USIS information to DIMITRANGPOULOS during ROUSSEN's USIS employment.); and, of course, DIMITRANGPOULOS.

According to ZAFEIROPOULOS (SGAA-33528, 29 Aug 58) no one in Kathimerinj had ever heard of DIMITRAKCECULOS before 1945 when he was introduced to ZAFEIROFOULOS by Leon MAKKAS. EIMITRAKOPOULOS apparently refused a salary and worked for several years for Kathimerini under this arrangement until he finally agreed to accept the sum of 2000 brs per month. His salary was never increased. He remained at Kathimerini until his dismissal after the publication of an article in late November 1957 which, in the opinion of many informed observers, touched off the antimissile campation which ran throughout the Winter and Spring of 1957/58.

The following items from Eleni VLACHOU's file are worthy of note:

In November 1953, Mrs. VLACHOU was one of 11 prominent Greeks, from conservatives to Communists, who visited the Soviet Union on invitation of the Soviet Embassy in Athens. While there she made a brondcast over Radio Moscow which was apparently distorted to sound very pro-Russian. The interview was harshly criticized by several Athens daily memopapers.

Two days before the departure of the group from Russia, Hrs. VLACHOU sent a cable to Kathimerian denying categorically the published version of the radio interview. A series of articles in <u>Kathimerian</u> by VLACHOU, giving her observations of the trip, is characterized in SGAA-7946 (19 Jan 54) as "a masterpice of observation and critical insight into the Soviet system and methods. By far, the series were the most penetratingly critical of all those written by the returning delegation."

EKAA-10662 (15 September 1964), reported that Eleni VLACHOU, Christos LAMBRAKIS, and the Athens News Agency (necording to Seviet Embassy First Secretary Vitaliy Grigoryevich NOVIEOV /201-1092407) allegedly were interested in collaborating in setting up an official TASS office in Athens.

State Department Telegram A 579 (22 Jan 65) concerns a conversation between an Embassy officer and VIACHOU during which Mrs. VLACHOU frankly admitted that opposition to ERE, including her own paper, had

CARRECTATED both the danger of Communism in Greece and the Center Union government's alleged weakness in meeting this problem,

> Hrs. VIACHOU is currently residing in London from where she attacks the Greek juith and the attitude of the U.S. toward the Greek military Government, with comments such as "it is impossible to believe that they had not definite information that the Americans would at least tolerate them." and "the coup succeeded because of NATO training and NATO tanks. What we have in Greece now is a NATO dictatorship."

D. According to THORATE/1 (Attnch. to EKAA-8878, 24 Oct 60), DIHITRAKOPOULOS first came to Source's attention right after the accupation when he met DINITRAKOPOULOS in Constitution Square with "Underminister of Press (fau) ALEXANDRAKIS." Source said that DIMITRAKOPOULOS would work for anyone and that the British were then using him to plant propaganda articles.

Headquarters files centain no record of an ALEXANDRAKIS in that position, and KGECRU states that they have no record of anyone by that name accupying the position of Underminister of Press during that period. However, EKAA-4996 (Attach. C, page 3) (See summary on Rade TROST below) mentions one raw ALEKSANDRAKIS, Ministry of Trade (circa 1960) who is probably identical with Nikitas ALEKSANDRAKIS, Greek Minister of Commerce 1957-58, and reportedly a contact of TROST, who was Yugoslav Counselor for Feonomic Affairs ( and known Yugoslav I.S.) in Athens 1957-60. We are unable to determine, however, if the iatter ALEKSANDRAKIS is identical with the former Underminister of Press.

E. In June 1964 (EXAA-10012, 12 June 64), THSALT reaffirmed that DIMITRAKOPCULOS cannot write and has little apparent income from his journalistic sources. Source said that he thought DIMITRAKOPOULOS has a secret partnership with Evangelos ANDROULIDAKIS and that DIMITRANOPOULOS and ANDROULIDAKIS had teamed up to sell commission of value to businessmen as well as to help businessmen get access to key positions. The following are pertinent Headquarters traces on ANDROULIDAKIS:

1) ANDROULIDAKIS, Evangelos (201-185637)

Born 1907, Crete Journalist (associated in past with <u>Rizospastis</u>, <u>Broia</u>; <u>Eleftheria</u>, <u>Kathiwerini</u>, <u>Vima</u>, <u>Naitemburiki</u>.

PGA-3929, 21 July 1949, reported that ANDROU-LIDAKIS, a Communist journalist, was one of the principal informants of the Soviet agent, VELICHANSKY (TASS correspondent, Athens) and worked closely with Nikolaus GIANNARAS, trenslator of radio news for <u>Akropolis</u>, GIANNARAS was reportedly an important member of the Communist Party and a dangerous conspirator. ANDROULIDAKIS reportedly was an unquestioning and tested agent of the press KOB of the KKE who worked in the field of anti-American intelligence. The journalist rembers of this KOB were reported to be protected for no good reason by powerful personages such as LAMBRAKIS\_and the entourage of Sofocles VENIZELOS, and the Soviet Intelligence metwork in large depends upon them. They have never been bettered by the police although there are important doculers of evidence against them.

> FGA-4728, 1 March 1950, carried ANDROULIDAKIS name on a list of journalists alleged to have actively collaborated with the Ecvict service. Prior to outlawing of the KZE, a list of trusted journalists were selected for information by the Soviets, once more on orders of VELICHANSKY.

SGA-3601, Dec 1955 (Names and telephone numbers of persons mentioned by KKE official Konstantinos TRIANTAFYLLIPIS) included the name of Evangelos AN-DROULIDAKIS in a list of subscribers in 1951 to Antaion, unoificial publication of the KKE front organization EPAN, with the statement that the pro-Communist record of most of the persons licted is well-known.

SGAA-12708, 19 Nov 1964, mentions ANDROULIDAKIS in connection with the Greek periodical Public Opinion (which was the conthly bulletin of the Greek Institute of Public Opinicu) and described him along with Theodore VOKOS an two forcer Communists who are listed in the periodical as comprising its directorship. It stated that Evangelos ANDROULIDAKIS is the cousin of George ANDROULIDAKIS, editor-in-chief of Eleftherin and also a former Communist. (It should be noted that Leon MARKAS, according to ATHE 0469, 21 Jan 58, was associated with Public Opinion which was described as a Communist-front publication.)

Per SGA-2341, 12 July 1954 (List of Communist and Leftist Journalints), describes George ANDROULINAKIS or ANDROULIDAKIS as having been a Communist for many years and very active before the war, for which reahe was repeatedly arreated by General Security. Whilel working as a reporter for Rizospantis in November 1928, he was sent by the KKE to various provinces of Greece in order to organize area committees for the election of representatives to the Fourth KKE Congress. He was declassified in 1941 after signing a statement of reported. After the liberation and a short time after the December 1944 Revolution he worked for Rizospastin and then for Machi.

THODIUM reported numerous contacts between George ANDROULIDAKIS (1959-61) and the Yugoslav Embassy, Greece (both with Veselin MARTINOVIC /201-2358397, Counselor at the Yugoslav Embassy and known Yugoslav I.S., and Dusan VURICEVIC /201-3347827).

THUNION/40 provided on 26 October 1964 (FKAA-14020, 6 Apr 66) a list of Communist journalists employed by nationalist newspapers, which included she name of George ANDROULIDAKIS.

P. Yugoslav Contacts of DIMITRAKOPOULOS

1) TROST, Rade (201-60121)

Counselor for Economic Affairs and known Yugoslaw Intelligence Officer (UDBA), Yugoslaw Embassy, Athens, from 1957 to circa 1960. CONTINUATION OF

EKA-765 (23 (ct 59) and ExAA-4996 (Attachment C) (dated 93 March 61) both report contacts between DIMITRALOPOLIES and Lade THORT. The latter disparch also reports contact between himitrics LLED 5. Greek TFA (Connercial Reprovementative) and TNCST. It should be noted that LAMBRON was a contact of DIMITRAKOPOLICS in reschington, D.C., in June 1862--(See Summary on LAMBRON below)

EMA-758 contains the information that DIMITRA-NOPOULCS is sidely considered by the Greek Security officials to be the rulin leak channel for the Tugoplays (via TROST) is plauting unattributible were and propayands in the Greek press.

ENAL-4996 (Source: THUDIUM) describes verious conversations between DIMITHAKOLUULOS and TEC.T. che, in Lartheelar, is worth noting: Ca 6/7 Jasuary 1960, DIMITRACIECTICS told THE.T he wan taking a crip to Farly "on the liness for about 10 days and will see General NUMERTAT and the other people." He audeo, "I always try to see the best people." PINITANE FOULOS also told TROOT that he would like to have o long conversation with the Yugoslav Antassacor and Thust before he departed on his trip because he wan going to write an article in Makedonia about Greek-Yugeslav allalrs and wished to sive the details to TROST and the Ambassader. (It chould be noted that in the spring of 1960, DIMITRAKOPOULCS published several articles concerning Greek-WATO negotiations. In Barch 1960. claiming Paris NATO officials up his source, he published an article concerning the establishment of a migsile training base in Grete. In May 1966, he published the articles in Ethnos, one concerning NATO detense plans for Greece in which he used the exact language of a Top Secret Greek Defease document, and a second one concerning an Italian decusent from NATO Liles which depicted Greek Epirus as Albealans and which resulted in straiged Italian-Greek relations.)

2) RIBARIC, Boris, Colonel (201-743591)

Yugoslav Eilitary Atlache, Athens circa 1965.

ERAA-13/64, 5 January 1965, mentions PIRITRA-KOPOULOS as being an "interloper" at a reception given by KIEARIC, and concents, "It is quite interesting that DIMITRAKOFORDOS was present (at the reception) since Hendmarters will recall previous reporting which linked him intimately to RIBARIC," (NCTS: a thorough search of both DIMITRAKOFOULCS' aid RIBARIC's 201 tiles failed to uncover may further mention of a DIMITRAKOFOULOS/RIBARIC relationship.)

The writer of the report, however, states that it is difficult to assess the validity of this charge although it had been made by periods who were not normally given to waking extremist partison judgments. He stated further that the basis for this charge may be LANDRES! personal friendship with several persons of known lefthet economic views.

In a WGDONE report concerning DIMITRAKCPOLLAS<sup>1</sup> contacts in the United States during his June-July 1952 visit, it is noted DIMITRAKGPOULOS was in telephonic contact with LAMBROS (then Counscior of the Greek Enbase;) at his wanhington, D.C. (Chevy Chuse, Nd.) home address!

According to EXA-4936 (Attachment C), Pade TRUST in 1:59-60 was in frequent connectant with Dimitries 1/2020S, described as "Commercial Representative." July downent also stated that TROST was cultivating several Greek WFA types.

2) "ccording to EKAA-14891 (1 Oct 66), Senstor Vence HARTEE, accompanied by his close friends, Mr. and Mrs. Elict JANEWAY, visited Greece in September 1966, and were wined and close by DIMITRAEOPOLLOS and introduced to many high-level Greek and other foreign government officials as his old and dear friends."

The Congressional Record, dated 22 March 1968, contains two items concerning interviews by DINI-TRAKOFOULCS with HARTKE and JANEYAY, respectively. (A copy is attached for your information.)

The following are lleadquarters and LNERGO traces on the JANEWAYS:

The following background summary, dated August 1952, was lurnished by LNERGO:

Eliot JANERAY was born in New York State on January 1, 1913. His father, Meyer JACOLSTRIN, was born in Russia but the nationality of his mother is unknown. On November 9, 1931, while attending Cornell University, JANERAY married Carol RINDSFOOS, an American citizen. After graduating from Cornell in 1932, JANERAY and his wife traveled to England for the purpose of furnuing their studies at the London School of Economics.

According to a reliable foreign source, JANEWAY and his wife left the United Kingdom on August 30, 1933, and traveled to the Soviet Union. This trip was reportedly influenced by Sergel DINALOV of the Russian Union of Revolutionary briters. Prior to making this trip, JANEWAY indicated that he was not a member of the Communist Party but intended to become one upon his return to the United States. During the period of time JANEWAY was in the Soviet Union, little is known of his activities, according to the reliable foreign source, other than the fact that he was employed as a typist and reporter for the Hondow "Daily News." While in the Soviet Union, JANEWAY and his wife reparated. She obtained a position as Moscow correspondent for the Mearat newspopers and he returned to the United Kingdom

for the avered rurped of continuing his studies of the Londar School of Homester, Neverber 24, 1933. JANFAY Cld not resume his studies on London, however, but left for austria in January 1953 where he remained for the weeks. He Lilepeder returned to the Laited Elucion accompanied by Derta Schlifter, an Austrina Communist.

According to the reliable foreign source, JANEPAY joined the Communist Farty of Great Britain in November 1933 and van a member of the Southeastern Sul-District. He is clieged to have carned a bad reputation with British Communists and on Nebruary 21, 1934, the London Daily worker" announced the exputation irom the Communist Farty of J. JANEPAY on the grounds of pulitical unreliability. This indivioual is believed by the reliable foreign source to be identical with First JANEPAY. JANEPAY left the United Kinge a for the United States on February 22, 1934, and upon reaching this country reportedly informed the American Communist Farty that he had been discipliced by the Communist Party of Great Britain.

Ellot JANENAY was at one time associated with the International Statistical Bureau, 70 Fifth Average. New York City, and with Fendleton, Dudley and Associates, 270 Broadway, New York City. He has at warlous times contributed articles to the following publications: "The Nation, "Asia" magazine, the "New York Times" Sunday Magazine Section, "Fortune magazine, "Life" magazine, "Deutsches Volksecho, and the Federated Press. In 1941 he was Associate Editor of Time, Incorporated. As of April 1952, JANETAY was identified as a consulting economist and business trends consultant for "Newsweek" magazine.

A news item appearing in the June 10, 1938, Isome of the "New York Times" indicated that Eliot JANFWAY was a cospeaker with Dr. Harry W. Laidler, State Confrom of the Socialist Party of the State of New York, in the opening sension of the annual conference of the League for Industrial Democracy. This conference was held at the Unity House, the Summer camp of the International Ladies Garment Workers Union at Porest Tark, Fennsylvania, on June 9, 1938.

(NUTE: Meadquarters files contain the following information concerning an individual who is possible identical with Berta MOLLERING, mentioned in above LNERGO summary:

A reliable source knowledgeable of Comintern activities in Europe during the 1930's advised that one Barbarn TARNAY, believed to be an alias used by one Bertha BUNGESS; was known to Comintern officials in England and Austria as Barbara ARCHER, Bertha TARNAY and Bertha HOLLKNING. TARNAY was recommended by Comintern officials in London in 1934-1935 for courier duties. She had previously worked for the Comintern in Austria, using the maness Bertha TARNAY and Bertha HOLLERING. Source is not knowledgeable of TARNAY's present connections or activities.

An LNGOLD visa check dated 31 December 1964. custaised the following biographic isformation on CUNTINUATION OF

An LNERGO report (dated 11 Oct 54) contains the information that the Yugoslav Delogation in New York City was the recipient of correspondence dated 20 July 1954 from Eliot JANEWAY, 270 Park Avenue, New York City. Another LNERGO report contains a reference to one Margaret JANEWAY whomade out a check, dated 11 December 1953, to byetotak Kosta MANDUKIC aka Kossara MANDUKIC (201-3060), who was known to be in frequent contact with Yugeslav Government officials in New York City. (See summary on Jack WAUSERMAN below for jurther faculion of MANDUKIC.) Headquarters traces on Margaret JANEWAY with Eliot and Carol JANEWAY.

In mother LNEEGO report (dated 24 Nov 54) concerning Louis FISCHER, aka FIGHER (201-3280), who, according to LNEEGO, has been considered by many to have been a Boylet agent for many years, Carol JANEEAY's name appears in a section entitled "Activities and Associates (of FISCHER) after the German-Soylet, Pact, August 1939," as follows:

An LNERGO source of unknown reliability furminhed information in 1942 which indicated that PISCHPR was in contact with Carol JANEWAY, 124 East 19th Street, New York City, in December 1941.

Another LNERGO source of unknown reliability advised on 7 October 1952 that Carol JANEWAY held rembership in the Communist Political Ausociation in 1954, and was a rember of the Sacco-Venzetti Club.

The above informant stated that Carol JANEWAY attended schools in Soviet Russia during the 1930'H when she visited that country (although source did not believe the schools were directly connected with the Communist Party), and that she had Communist literature in her spartment.

According to the above LVERGO report, PISCHER recalled having met Carol JANEWAY and her mother in Eucoin during the 1930's. He said she was an awateur painter or artist.

3) WASSERMAN, Jock (201-240834)

An UNFEGU report dated 26 August 1964, indicates that WASSLERSS had made out a check in the amount of \$125,00 to one Svetovar RANDURIC (201-3660). MASSURIC, of Yogowiav extraction, was negotiating with the Yugonlav Government regarding the contruction of a rayon will in Tugoslavin, and vas in frequent coulact with Rade TSOST. Connectial Attache at the Yugoslav Consulate in New York City in 1954. (NOTE: TROST was in Athens 1957-59, and had frequent coulacts with DimitrARCFOCLOS. See Summary on TROST.)

Svetownr USNOUKIC and his sile LOBOARS MANDUKIC (nce MILOTKOWIC) have been vortoucly reported primarily by sources in furkey on collaborators of the Germans during Nor'd sarris, agents of Cath (the Yugoslay Intelligence and Security Bervice) and the successor intelligence organization UBB, and possible Soviets agents or informants. MANDUKIC's file however indicates that the information may have originated from two Yugoslav sources which sere considered unreliable and prejudiced. An LNERGO report, however, dated 29 July 1950, stated that Konsera MANDUKIC was reportedly in contact with an alleged Yugoslav...intelligence agent in New York City, and described her as a person of loose morals. Another LNERGO source stated that she would be the type of individual who would carry out an intelligence ausignment for a Yugunlay Govenneat official if requested to undertake such an assignment.)

3. Given the background of some of the personalities involved, it is possible that the master plan was laid in 1950-52 to establish the image of DIMITRAKOPOULOS as a pro-American (pro-vestern) patriotic journalist of great depth. Unfortunately, we can only surmise the true reanons behind the plan. We do know, however, that it was around this period that DIMITRA-KOPOULOS suddenly became an entity and a thern in the side of Greece/U.S./MATO in matters of mutual interest. It was also at this time that DIMITRAROFOULOS apparently falsified his age to deliberately create the image of a mature educated individual well versed to the political strategem of international affairs. Now successful he was at attaining this goal we have living proof. Now he accomplished this with little or no formal education is still a systery. fie do not helieve he could have managed this without belp. But who his mentors were (are) is still unknown to us. Con-sidering the type of individuals who were closest to him during the formative years of his "image making," any one of several could have conspired with his for this purpose. Leon MAKKAS, for example, could have played a very large. role. We should not discount Eleni VLACHOU's role, either, an one of his early employers. PAPAGEURGICU is certainly suspect aince it was his newspaper which first published the story of the heroic Elias, and it does not appear that he checked his facts very carefully, and so on down the line.

4. DIMITRAROPOULOS is still in the U.S., and continues to theel and deal with prominent personages. For example in June, he appeared at the Indianapolis 500 Auto Race and was introduced on the radio by Remator MANTES of Indiana, as "that important Greek correspondent from Greece, DIMITRANOPOULOS." He also counteed through HASTER to nee Luke MATTLE at State Department. Attached for your information in a copy of a Memorandum for the Bacord comparising







1. The above subject, bera January 8th 1910 at Matyfalva, Bungary, is presently ap lying for a U.S. immigration view at Montreal. According to the reserve of the Prefesture of Police about the relater-in-law of Feter NOTH, one of the co-veners of the IUKARO Company in Paris who reportedly emigrated to Ganada in 1949. She is also reported to be the owner of 248 of the original one thousand shares of the FIKARO Company. According to the same source the FUKARO Company had been reported by UNSCAPO as being a cover for Soviet espione age activities in France. Subject is qualified as suspect by reason of her donneetion with the FUKARO Company.

2. Subject use refused a visa at Montreal on July 3rd 1950 on the basis of the above information furnished by this office to the Visa Section in Paris on 19 April 1950. The basis for refusal was "entry prejudicial to the public interest" Subject's case has now been reactivated following receipt in Montreal of a memorandum from the Department of Statesenelesing to standards from residents in the United States, including one Jack MASSENAN, an attorney in Machington, 0.6., supporting-subject's visa applications.

3. Subject has now requested that her case be reviewed, stating that although she was aware of her brother-in-law's tusiness dealings, she disapproved of them and purroled with him because of his affiliations. 



1. The above subject, bern January 8th 1910 at Matyfalva, Hungary, is presently ap lying for a U.S. imigration visa at Montreal. According to the records of the Profecture of Sulica she is the sister-in-inw of Peter W(TH, one of the so-comers of the HIXASO Company In Paris and reportedly emigrated to Canada in 1949. She is also reported to be the cupper of 248 of the original one thousand shares of the POXIND Company. According to the same source the FURARD Company had been reported by UNDURIND as boing a cover for Soviet sapionare activities in France. Subject is qualified as suspect by reason of her conneotion with the PHKAHO Company.

2. Subject was refused a view at Montreal on July 3rd 1950 on the basis of the above information furnished by this office to the Visa Section in Paris on 19 April 1950. The basis for reflect was "entry prejudicial to the public interest". Subject's onso has now been reactivated following receipt in Montreal of a menarandum from the Department of State enclosing tratimonials from regidents in the United States, including one Jack MANAN, an attorney in Machington, D.C., sup-porting subject's visa application.

3. Subject has now requested that her case be roviewed, stating that although she was aware of her brother-in-law's business dealings, she disapproved of them and quarreled with him because of his affiliations. She further stated that she was never a shareholder in any of his enterprises. It is a matter of record, however, that her application for an exit visa for Canada in April 1949 was supported by a letter from the FULARD Company stating that she and proceedine to Connita on business for the fire. Thile in Farls she livel at 71 rue des Bolles Fouliles, the address of the rutano Company in Paris and reportably a building owned by ROTH.
