

HOPED TO MEET HOLDEN ROBERTO, SUBJECT LEARNED OF THIS APPROACH AND SINCE SUBJECT SAYS HE IS A CLOSE FRIEND AND SUPPORTER OF DANIEL GIPENDA, HE PUT STURGIS. IN TOUCH WITH VICTUR FERNANDER, SUBJECT SAYS THAT AT THAT TIME HE DID NOT KNON WHO FRANK STURGIS WAS.

8. VICTOR FERNANDEZ WAS IDENTIFIED AS ONE OF THE PERSONS INVOLVED IN THE ABORTIVE COUP OF MAY 1977 IN ANGOLA. STURGIS TOLD FERNANDEZ THAT HE REPRESENTED A GROUP OF CUBAN EXILES AND WAS IN A POSITION TO MAKE AVAILABLE 2000. ANTI-CASTRO CUBANS WHU WOULD GO TO ANGOLA TO PARTICIPATE IN ANOTHER COUP TO OVERTHROW THE CURRENT ANGOLAN REGIME.

C. STURGIS AND FERNANDEZ REPORTEDLY SIGNED AN AGREEMENT IN LONDON WHEREBY STURGIS PLEDGED FINANCIAL AND MILITARY SUPPORT (ACCORDING TO SUBJECT AFROM SOME LATIN AMERICAN GOVERNMENTS) AND AGREED AS TO WHO THE NEW MEMBERS OF THE GOVERN-MENT IN EXILE (I.E. ANGOLA) WOULD BE.

D. GIPENDA, WHO AT THE TIME WAS IN LONDON, WAS SUSPICIOUS OF STURGIS BUT WENT ALONG WITH FERNANDEZ' GETTING HELP FROM STURGIS. GIPENDA THEN WENT TO GENEVA WHERE HE HAS BEEN EVER. SINCE IN AMAT HOTEL. GIPENDA HAS BEEN WAITING AROUND, ACCORDING

1. As the result of an article on Subject in the 13 June 1976 <u>New York Daily News</u>, LA/COE was asked to do a file check to determine whether Subject was ever connected with the Agency. According to a EA/EOE Dest check: IP trace; CI/OA and Security Office check, LARINZ has never been employed by the Agency. Of interest, however, is the fact that her sister, Val eric LORINZ, was granted a CSC on 14 July 1955, initiated by Finance Division, as a witting employee. At that time Valeric was an employee of the National Bank of Nashington.

2. There are several references, sourced to the FBI and DCD. LORENZ is a self-admitted former girl friend of Fidel CASIRO. She claims that she met Fidel while on a trip to Cuba with her father, Captain of the North German Lloyd Line, in February 1959, became infatuated with Fidel and stayed in Cuba. She served as Fidel's mistress and came to the U.S. with Fidel's party in April 1959. She learned at that time that she was pregnant by him. Marita returned to Havana a short time thereafter and hadra miscarriage. She claims that she was drugged and taken to a hospital where an abortion was performed. Because of Fidel's reaction to the pregnancy, she turned against him. LORENZ returned to the U.S. from Cuba on 9 December 1959. Because of the bad abortion operation performed on LORENZ in Cuba in September 1959, LORENZ was-operated on by a Dr. Hanniar on 20-January 1960 at the Roosevelt Hospital in New York City. 3. It is said that LORINZ appeared on the <u>Today's Show on 14</u> June 1976. She reportedly made the statement that she was associated with Frank STURGIS, and that she had placed some poison pills in her face cream for the purpose of assassinating Fidel: A 24 April 1961 FBI document states that on 8 January 1961 LORENZ, STARGIS, Alex RORKE were to meet that evening and attempt a unity meeting of anti-Castro Oubans. The unity meeting was sponsored by Luis CONTE. Aguero; one of the leading anti-Castro Oubans. I have uncovered nothing to date concerning an assassination attempt (in this connection.)

1. According to a source of the Miami Field Office of the Domestic Collection Division, Subject disclosed to the source the following information concerning plans which allegedly reflect Subject's interest in Africa and Panama in conversations held on or around 5 June 1977. Subject has discussed plans to establish a Cuban Government in exile on Angolan soil with the help of Holden ROBERTO, FNLA. Subject is prepared on receipt of agreement from Roberto to provide food, medical teams and other forms of assistance to the FNLA. Ostensibly, this would be a first step following recognition by Roberto of a Cuban Exile Government. This government would then attempt to raise troops and, among other things, capture as many Castro soldiers as possible in order to use them as an exchange or trade instrument. The funds for such an enterprise ostensibly would come from Cuban Communities in Brazil, Nicaragua, Panama, Mexico, Venezuela and the United States. One aspect of the proposed unconventional war is the use of counterfeit Angolan money. Also allegedly involved is planning to secure Angolan aid for Panamanians who oppose Torrijos.



3. While in New York STURGIS saw Marita LORENZ and obtained from her a book which, according to source, appeared to be cryptographic material and second to relate to Albania. The DCD source saw a "few copies" of what he described as "mathematical matrix" material.

4. STURGIS currently (today - 23 August) is attempting to contact Senator Bakor to turn over the material to him. DCD plans to ask the source to menitor the situation and advise whether the material in fact is turned over to Baker.

1. This morning I received a phone call from the COS, Miami who advised me that yesterday Frank Sturgis called the DCD, Miami Office, and expressed a desire to meet with one of the DCD officers. Sturgis claimed to have new information on the movement of narcotics through Mexico and other information which he did not specify.

The DCD Miami Office thanked Sturgis for calling and referred him to the FBI and DEA, who would be the most interested recipients of the information he has. Sturgis was very pleasant on the telephone and the DCD people obviously responded correctly.

Cubanos Unidos (CU) is a Cuban exile anti-FIDE CASTRO organization in Niami, Plorida. Its purpose is to unite all exile groups into a unity organization and begin military operations against the present Government of Cuba.

WILFREDO NAVARRO DEATO is the head of CU. which organization now maintains office space at 1996 S. W. 1st Street, Miami, telephone 642-9741,

On June 9, 1970, NM T-1, a Cuban exile involved in revolutionary matters for the past six years, advised that CU recently decided to start selling bonds issued in the name of the Republic of Cuba. The money collected would be used to purchase arms for proposed military operations against Cuba.

On June 15, 1970, MM T-1 stated that WILFREDO NAVARRO at that time was claiming that MAURICE FERRE. member of the Miami City Commission. is assisting him i member of the Miami City Commission. Is assisting him in-Cuban revolutionary activitios. KAVARRO claimed that about a woek previously, a meeting was held in the PFRRE. Building in Miami, and it was determined that CU had adequate money resources. NAVARRO said that he instructed TOMAS ARENCIBIA, a leading member of CU, to ould his job and NAVARRO would pay his salary. NAVARRO explained that he wanted ARESCIBIA to work on a full-time basin for CU. Also present at this meeting were three unidentified Amoricans, one of whom reportedly has a quantity of arms stored at his house.

On June 19, 1970, MM T-3, another Government agency which conducts intelligence investigations, advised information had been received that GU recontly held a meeting to introduce Americans who are backing their organization. The Americans were FRASK FIORINI and ED KAISER. FIORINI calls himsolf the "Chief of Intelligence Section of Cubanos Unidos".

On July 1, 1970, WHEREDO NAVARRO BEATO appeared at the Miami Office of the FBI with his brother, ROFRNE NAVARRO BEATO, and advined as follows:

FRANK FIORINI. an American citizen who has been involved in Cuban exile revolutionary matters for the past ten years, recently signed a unity agreement with CU. In this agreement, FIORINI, who represents some independent anti-CASTRO organization, agreed that political unity of all exile groups must be established. FIORINI is not a member of CU as such, holds no official position, and is not in charge of intelligence.

NAVARRO caid that a few days previously he returned from Washington, D. C., where again he was trying to obtain United States Covernment support and backing. He was told that no support could be given unless it was personally authorized by President RICHARD M. NIXON.

They stated that JORGE CONZALEZ, also known as "Rombillo", who was formerly associated with another anti-CASTRO organization, was in no way associated with CU. They claimed that CU had no plans to attack a Russian vessel off the coast of Florida. CU had previously said it needed some 57mm recoilless rifles for this purpose but had no intention of attacking a Russian vessel. Announcements that they were going to do so were made for political propaganda and also to stir patriotic Cuban exiles to become more active in Cuban revolutionary matters.


