J. Lit is requested that the Headquarters reviewing action 6 described in Reference C for handling the cases of MOLINA ORTEGA and MOZO be expanded to include all the remaining cases and that JMWAVE be informed of the conclusions reached concerning the ultimate disposition of these cases.

4. FYI. An amount of \$250,000 was originally authorized for the medial phase of the AMEUD Program. Expenditures under this program have reached a level of approximately \$245,000 with bills outstanding at the present time of \$3,250. It is evident that the cases remaining which require medical treatment as outlined above will necessiate the expenditure of sums in excess of this amount.
