- (1) This amount of \$225.00 corresponding to Felipe Morin Rodriguez, has been split ever since September 1, 1963 in accordance to an order of the Justice of the Peace, by which, the amount of \$60.00 is paid to his wife Elia Maceo, and the rest, -- \$165.00 to Felipe Morin.-
- (2) Lorenzo Pardo Jimenez is at the National School of Heavy Equipment Operation and this Office has been instructed to pay him only until February 1964.-
- (3) (4) (5) These three are not invaders of the Bay of Pigs. They belong to the group that was supposed to receive Nino Diaz at the landing point on April 1961. Their payments started on August 15, 1961, at the rate of \$20.00 every 15 days, directly to each one, without considering dependants.-
- (6) Not considered in this amount the \$250.00 Bonus paid to each one of them.
- * This group of 21 has been ordered by Dr. Maceo, not to receive any more payments after December 1963. There exists the possibility that some of this group of 21 might be ordered by Dr. Maceo to keep making payments to them, because they have not completed their medical treatment.-
