AS STATION AWARE, THERE IS A GREAT DEAL OF INTEREST IN *THE EVENTS SURROUNDING THE ASSASSINATION > OF < JFK > OVER THE PAST YEAR THE AGENCY HAS BEEN REVIEWING ITS DO HOLDINGS (AS WELL AS OTHER GOVERNMENT COMPONENTS' MATERIALS AFFECTING DO EQUITIES) *PRIOR TO ANY RELEASE TO THE NATIONAL ARCHIVES UNDER THE < JFK > *<ASSASSINATION > RECORD COLLECTION ACT OF 1992. INCLUDED IN THE REVIEW IS INFORMATION ALREADY RELEASED BY THE AGENCY UNDER FOIA AND IN THE PUBLISHED CONGRESSIONAL INVESTIGATION FINDINGS OF THE *<ASSASSINATION. >
