1. ON 13 DEC SMITH REP MEXI, RICHARD WALLIS, SUBMITTED TO CCS POSSIBLE AUDIO CP AGAINST APT OF PIOTR VASILUX (201-112135).

WALLIS' SECRETARY LIVES IN ADJOINING APT WHICH COULD BE USED TO INSTALL PROCS MINEG INTO VASILUX APT.

2. WALLIS CLAIMS HE APPROACHING KUDARK BECAUSE CONER, RUSSELL FISCHER, (CUBA) (C/CI), IS AMERICAN CITIZEN AND FACT THAT SINCE WALLIS' BODY BELIEVES APT RAIDS WOULD INVOLVE FISCHER IF ANY SUSPICIOUS ACTIVITY IN BUILDING, OPS PLAN WOULD HAVE TO INCLUDE HITTING USE FISCHER.

3. CCS TOLD WALLIS STATION WOULD CHECK OUT FISCHER WITH OUR HQS AND ALSO DETERMINE IF KUDARK INTERESTED JOINT OP. NOT CLEAR TO WHAT EXTENT KUDARK FUNDS, EQUIPMENT AND TIME WOULD BE REQUESTED BY SMITH IF KUDARK SHOWED ANY INTEREST.

4. STATION RECOMMENDS AGAINST SUSPECTED RUMORS OF FACTS

A. DO NOT BELIEVE THAT WOULD WARRANT EXPENSIVE AND TIME AND JOINT ACTIVITY WITH CROCK.

B. DESPITE FACT HAVE BEEN ON FISHER RECENT ACCIDENTS WERE SEEN HER TRIP TO LEADER CAME FROM CROCK INDICATE NO COOPERATION IN MAKING MONEY, WOULD VERY PROBABLY NOT WANT TO RISK COOPERATION UNLESS GAIN OFFERED CONSIDERABLE. WORTH NOTING THAT OF FOUR BUILDINGS OWNED BY FISHER ALL HAVE AT LEAST ONE IF NOT MORE OFFICIAL POLICY FAMILIES OR CHURCH GROUP BEING FORMED. DESPITE FACT ABOVE INFO CIRCUMSTANTIAL, LACKING ANY PLausible EXPLANATION FOR HIGH INCIDENCE BOMB TYPES IN HIS CITIES, STATION RECOMMENDS AGAINST BELIEVING HIM.
