The following information has been received from Asbaseador Timone, Port-eu-Prince, Meiti:

In view considerable attention and in MYInco Nov. 24 to Mr. sad Mrs. Guorge de Nobrenschildt, and their toetimeny before Watton Commission, Dept should have folllowing facts about their activities in Naiti.

In an incident arising out of alleged custody of a dog, Mrs. do Mobrenschildt recently created a public scene in End reception area, pursued End receptionist (local employee) into ladies' recon and elapped her. Wee. de Mobreuschildt then returned later, bereted Marine Giard, and cureed receptionist to my face. This incident only cultination of recent series of unpleasant episodes inswich de Kourenschildts involved, including attempt macie in on And Charissary. As result, and to protect my staff egainst such arregant and bratal treatment, I have told so Mobrenschildts that before they may take up any matter of business in Eab, they must see DCM, who will make necessary errangements if business is justified.
