Re Bern letter 1/5/65.

On 1/6/65 [JOHN DIMMER, ]

the Embassy, Bern confidentially informed that he had learned that LANE was to speak in Zurich, Switzerland, some time in the next two weeks on the subject of OSWALD's innocence in the killing of President KENNEDY. LANE's talk is allegedly to be sponsored by HEINRICH BUCHBINDER, well known Swiss Trotskyite who is prominent in the Swiss Movement Against Atomic Armament (Schweizerische Bewegung gegen die Atomare Aufrüstung - SBGAA)

At [DIMMER's] request, he was furnished background material concerning LANE. [DIMMER] stated that he would keep this office informed of further developments in this matter.
