4) Will locate and interview Miss BERRY ALBERTSON, 5925 Northeast 6th Avenue, and her friend, Miss SALLY HOY, concerning subject's activities and any statements he might have made concerning being a representative of the United States Government.

## ADMINISTRATIVE

One copy of this preport is designated for Philadelphia for information inasmuch as there are outstanding leads in this division.

During interview of Mr. KEITH WADE, subject appeared and said he understood the FBI was investigating him. He voluntarily furnished information set forth in instant report.

Subject advised that KATHLEEN ANN BERNS was the victim of a vicious rape attack on August 25, 1961, at which time she was taken to a hospital, is in poor physical condition, and is extremely nervous from this experience and the following police interrogation.

In view of her physical condition, and the fact that she is living with the subject, she was not interviewed.

The interview of subject on July 24, 1961, was handled under the caption "GEORGE DAMAN, IMPERSONATION", which was subsequently closed administratively. At that time a search of the indices failed to reveal the existence of the Neutrality Matter, Impersonation case under his correct name.
