Agent DeLoach has confidentially ascertained that the Central Intelligence Agency plans to place a representative in Ottawa, Canada (I) within the next several weeks. This representative will reportedly be one Samuel Herman Horton, a former Bureau Agent who resigned in December, 1944 to accept a position with the Office of Strategic Services.

Bureau Agent and now an employee of CIA, has recommended that only a former Bureau Agent should be placed in Canada so that the proper relationship could be initiated with FBI Liaison Officer Glenn H. Bethel Harvey has further stated to his associates that any former Bureau Agent now working for CIA can (II) gain the confidence of Bethel and thereby have an entree with the Royal Canadian Mounted Police and other excellent contacts established by Betherland the FAI throughout the years. Harvey hasalso reportedly stated that, due to Bethel's "peculiar personality", heefeels it necessary that Horton be assigned to the job in question so that Bethel might be properly handled.
