1. An Italian intelligence service has requested this agency for information on Armada BECEA (DPOB: 15 August 1917 in Albania), bearer of U. S. Passport No. 2427216, issued 10 August 1960. The Italian service (5) claims that Subject was recently in touch with persons suspected of collaborating with the Albanian Intelligence Service, with no further details given. The Italian service did not indicate whether Subject(5) contacted the suspects in Italy or elsewhere. The Italian service 7(3) has been asked to supply more details; their reply will be transmitted to you when received.

2. We will appreciate your supplying us with any vital data and/or identifiable derogatory information on Subject which can be passed to the Italian service. This Agency has no other information on Subject.

3. Copies of this request are being sent to the Department of State and the Immigration and Naturalization Service. Early replies will be appreciated from all addressees.
