Captioned matter was discussed with Mr. LAUGHLIN CAMPBELL, Chief, CIA, Paris, and his assistant, DARWIN CURTIS, on 6-3-64. Assistant Legat RICHARD E. POTOCKI discussed the case with [DAVID LAUX] of CIA on 6-10-64. These individuals advised that so far as they know, GIBSON is still employed by the magazine "Revolution" which now has its headquarters in Paris. They stated that [they have not made contact with him although they have not abandoned the possibility of developing him as a source. LAUX] who is handling instant matter for CIA, Paris, stated he would keep this office advised.

We will continue to follow and keep the Bureau advised.
