

Carlos Antonio Piad y Del Pino

Carlos Antonio Piad y Del Pino, a Cuban exile residing in Washington, D. C., had been interviewed by representatives of the Federal Burbau of Investigation (FBI) in Washington. D. C., on June 6, 1968, relative to a "report" alleging great discontent in Cuba against Prime Minister Fidel Castro which he had received. Piad stated that the "report" was from a female friend in Cuba whom he declined to identify, and he said that this "report" was received in the mail addressed to his wife. Plad also said that he did not now have this written "report" which was received from the woman in Cuba. Plad said that he was certain that there was an apparatus in operation in Cuba which was flighting Prime Minister Castro, but "reports" were vague and he had no clear idea of this matter. Piad was of the opinion that Carles Repadino, 37 West 47th Street, Hew York City, of Corletto (phensile) Jauslay and "El jirgo" Robrano in Madrid, Spain, could throw more light on the matter. E).

Piad, in a letter to the FBI dated June 6, 1968, among other things, furnished the following:

> "I am totally ignorant of any plans which (Commandance (Faure)) Cheson ((Ct:5an Miaicter only schething I have been made aware of. Without being able to furnish anything concretely. I did , wish to bring to the attention of the Department of State something they ought to know about. Τ can say that I have friends in the company group and that I understand they have never been Communists, but I repeat that I have not had contact with Consumdants Chonon or his friends I have had only a report from a up to now. female friend from Havana who has knowledge of this matter. ### Carlos Antonio Piad y Del Pino

"This is more or less the substance of all that I wanted to bring to the attention of the Department of State so that they might know about what appeared to be a plan aimed at the assessination of Castro, and that it appeared that Corrandante chowod and his friends were involved in it in some way. Also, I related that although Castro was a closely guarded man, Groson was a dangerous man, and I cited the case of Boundienne of Algeria whom they tried recently to assassinate. I explained that from what I have read Boumedianne is one of the most glosely guarded men in the world other than Castro and that it is unoredictable what he is going to do."

Carlos Topedino, 31 West 47th Street, New York City, was interviewed on December 5, 1958. Acteding currently is President of the joyelry film known as Tishaan and Lire; Incorporated, and also of the firm, Corlitto. Incorporated of Milan, Italy. Both these firms are located on the third floor of the building at 31 Most With Street, New York City, and Horest Hills, Onese, Key Fork. In addition to the above-mentioned componies, Tageding is also connected with the Science store in Geneva. Switzerland which is operated by Juan Venture. In connection with his fereling business, freeding travels frequently to Europe, particularly to Italy, Spain and France.

Repeating advised that in 1966 there was a conspiracy to assassinate Prime Minister Fidel Castro, and that he had a part in this plot. During the period 1964, 1965 and 1966, Active stated that he was on good relations with members of the Cuban Government who were assigned to posts in Spain, Italy and France, and also with the members of the Cuban Mission to the United Nations. Monodimo stated as a result of these contacts, he was trusted by members of the Cuban Government and was in a position to obtain information of value which was of assistance at that time in working out details of the plot to kill Prime Minister Fidel Castro.

Topeding stated that after the discovery of this plot, all his contact with representatives of the Cuban Government in enhancies and consulates in foreign countries ceased. Topeding stated that he was no longer trusted by anyons within the Cuban Government and, hence, lost contact with Friends in Havana, Cuba. Foreding advised that currently he has no direct contact or even indirect contact with any officials of the Cuban Government in Havana. Topeding also pointed out that although he know Communic Taure Chorles, he never was a personal friend of his, nor has he had any indication that Cuton may currently be involved in any plot spainst Fidel Castro.

Tepeding also stated that since the discovery of the plot in 1966, although he has hade many trips to Spain, he has had no further contact with dor a Robrence, also known as "Manoo". Tepedinossaid that Robrence / sometime ago, left Madrid and currently is residing in Barcelcha, Spain, where he is managing a Cuban fighter who is alleged to be a European boxing champion.

Temodimo stated that he knows that there is much unrest and discontent within Cuba today, but he has no knowledge of any details of any plot which could exist against Fidel Castro in Cuba today.
