In connection with its investigation into the circumstances surrounding the death of President John F. Kennedy, the Select Committee on Assassinations requests access to the personnel files of present and former CIA employees who were recently interviewed by Staff Investigator Harold D. Leap to determine the exact period of time the individuals were stationed in [Japan] between 1959 and 1964.

The list of names will be submitted at a later date under separate cover.

The information requested is important to substantiate or discredit certain allegations that are of concern to this Committee.
